**Planning Proposal PP\_2016\_THILL\_008\_00 – Alteration of Gateway Determination**

I refer to your letter in relation to planning proposal PP\_2016\_THILL\_008\_00 seeking an extension of time for the proposal which proposes to rezone land at 93-107 Cecil Avenue and 9-10 Roger Avenue, Castle Hill, to B4 Mixed Use, provide for a bonus floor space ratio of 3.5:1, and remove the maximum height of buildings control.

I have determined as the delegate of the Greater Sydney Commission, in accordance with section 56(7) of the *Environmental Planning and Assessment Act 1979*, to alter the Gateway determination dated 2 November 2016 for PP\_2016\_THILL\_008\_00. The Alteration of the Gateway determination is enclosed.

The Alteration of Gateway determination provides an additional 6 months until 9 May 2018 to complete the proposal. This is considered a sufficient period to allow finalisation of the proposal as community consultation has already been completed.

I note that Council is currently addressing issues raised in submissions, particularly those raised by agencies in relation to the traffic management. Assistance is available from the Department's accelerated rezoning team to help Council finalise this matter.
