Planning proposal to amend Nambucca Local Environmental Plan 2010 to reclassify land at 86 High Street, Bowraville

I am writing in response to your Council's correspondence dated 28 August and 20 September 2013 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to amend the Nambucca Local Environmental Plan (LEP) 2010 to reclassify Lots 1 and 2 DP 1088352, 86 High Street, Bowraville from 'community' to 'operational'. Thank you for providing additional information on 17 October 2013 to enable the matter to proceed.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

Council is reminded of its obligations for undertaking a public hearing in relation to the proposed reclassification of land in accordance with the Department's *Practice Note PN09-003, Classification and reclassification of public land through a local environmental plan.* In particular Council should note that the public hearing must be held after the completion of the period of community consultation.

I note that Council has provided a land titles search that indicates there are no interests in the land. I also note that Council has indicated the land is not identified as a public reserve.

I have also agreed the planning proposal is not inconsistent with any S117 Directions. No further approval is required in relation to these Directions.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has now accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the department for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2013_NAMBU_005_00): to reclassify Lots 1 and 2 DP 1088352, 86 High St, Bowraville, from 'community' to 'operational'.

- I, the Regional Director, Northern Region at the Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to the Nambucca Local Environmental Plan (LEP) 2010 to reclassify Lots 1 and 2 DP 1088352, 86 High St, Bowraville, from 'community' to 'operational' should proceed subject to the following conditions:
- 1. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
 - (a) the planning proposal must be made publicly available for a minimum of 28 days; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013).
- 2. Council is to conduct a public hearing in accordance with requirements of section 29 of the *Local Government Act 1993*. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act.
- 3. No consultation is required with public authorities under section 56(2)(d) of the EP&A Act.
- 4. The timeframe for completing the LEP is to be **9 months** from the week following the date of the Gateway determination.
