Planning proposal to amend Kyogle Local Environmental Plan 2012

I am writing in response to your Council's correspondence requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 (the Act) in respect of the planning proposal to rezone land at 6399 Kyogle Road, Kyogle and the adjoining road reserve for industrial purposes and alter the minimum lot size provisions.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed, as delegate of the Secretary, the planning proposal's inconsistencies with S117 Directions 1.2 Rural Zones and 5.3 Farmland of State and Regional Significance on the NSW Far North Coast are justified in the terms of the directions. No further approval is required in relation to these Directions.

Council will still need to obtain the agreement of the Department's Secretary to comply with the requirements of S117 Direction 4.4 Planning for Bushfire Protection. Council should ensure this occurs prior to the plan being made.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet

these commitments, the Minister may take action under section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2017_KYOGL_003_00): to rezone land at 6399 Kyogle Road, Kyogle and the adjoining road reserve for industrial purposes and alter the minimum lot size provisions.

I, the Acting Director Regions, Northern at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Kyogle Local Environmental Plan (LEP) 2012 to rezone land at 6399 Kyogle Road, Kyogle and the adjoining road reserve for industrial purposes and alter the minimum lot size provisions should proceed subject to the following conditions:

1. Prior to consultation being undertaken a Land Use Conflict Risk Assessment (LUCRA) is to be undertaken addressing the potential land use conflicts that may arise due to the rezoning and subsequent use of this land with the surrounding residential dwellings and any other sensitive receptors.
2. Prior to consultation being undertaken the Planning Proposal is to be amended as follows:
 - (a) a Location Map is to be included identifying the subject land;
 - (b) reference to the proposed change in minimum lot size provisions to 1500m² on the site is to be included;
 - (c) reference to the proposed change in zoning and minimum lot size provisions for the adjacent portion of Kyogle Road is to be included;
 - (d) mapping showing the current and proposed minimum lot size provisions is to be included;
 - (e) inclusion of the completed LUCRA and any necessary changes to address its recommendations; and
 - (f) reference to the Far North Coast Regional Strategy 2016-2031 and the Draft North Coast Regional Plan are to be removed and replaced with discussion on the North Coast Regional Plan 2036, including addressing the consistency of this proposal with the Plan.
3. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal is classified as low impact as described in *A Guide to Preparing LEPs (Department of Planning and Environment 2016)* and must be made publicly available for a minimum of **14 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Department of Planning and Environment 2016)*.

4. Consultation is required with the following public authorities under section 56(2)(d) of the Act and/or to comply with the requirements of relevant S117 Directions:

- NSW Rural Fire Service
- NSW Roads and Maritime Service

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

5. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
6. The timeframe for completing the LEP is to be **9 months** from the week following the date of the Gateway determination.
