# Planning proposal to amend Corowa Local Environmental Plan 2012 – Lots 11 & 12 DP 737090, Melbourne Street, Mulwala.

I am writing in response to your Council's letter dated 27 June 2013 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 (EP&A Act) in respect of the planning proposal to rezone part Lot 11 DP 737090 and part Lot 12 DP 737090, Melbourne Street, Mulwala from zone W2 – Recreational Waterways to zone R1 – General Residential and amend the related Land Zoning Map, Lot Size Map, Height of Buildings Map and River Front Building Line Map.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed that the inconsistency with section 117 Direction 4.3 Flood Prone Land is of minor significance and no further approval is required in relation to this Direction.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office (parliamentary.counsel@pco.nsw.gov.au) 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department for administrative purposes at planmaking.monitoring@planning.nsw.gov.au..

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

## **Gateway Determination**

**Planning proposal (Department Ref: PP\_2013\_COROW\_003\_00)**: to rezone part Lot 11 DP 737090 and part Lot 12 DP 737090, Melbourne Street, Mulwala from zone W2 – Recreational Waterways to zone R1 – General Residential and amend the related Land Zoning Map, Lot Size Map, Height of Buildings Map and River Front Building Line Map.

I, the Regional Director, Western Region at the Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to the Corowa Local Environmental Plan (LEP) 2012 to rezone part Lot 11 DP 737090 and part Lot 12 DP 737090, Melbourne Street, Mulwala from zone W2 – Recreational Waterways to zone R1 – General Residential and amend the related Land Zoning Map, Lot Size Map, Height of Buildings Map and River Front Building Line Map should proceed subject to the following conditions:

- 1. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 (EP&A Act) as follows:
  - (a) the planning proposal is classified as low impact as described in A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013) and must be made publicly available for a minimum of 14 days; and
  - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013)*.
- 2. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act.:
  - NSW Office of Environment and Heritage
  - NSW Office of Water
  - Roads and Maritime Services
  - DPI Fisheries

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

- 3. Council is to prepare amended maps for the Section 59 submission that are compliant with the Departments Standard technical requirements for LEP maps. The following related maps are to be amended:
  - Land Zoning Map (LZN\_003A)
  - Lot Size Map (LSZ\_003A)
  - Height of Buildings Map (HOB\_003A)
  - River Front Building Line Map (RBL\_003A)
- 4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).



The timeframe for completing the LEP is to be **12 months** from the week following the 5. date of the Gateway determination.
