Request for an Altered Gateway Determination – Former RAAF Stores Depot and Other Matters – Planning Proposal (PP_2014_DUBBO_001_00)

I refer to your letter of 31 August 2015 based on Council meeting of 24 August 2015 (PDC15/30) in relation to Planning Proposal PP_2014_DUBBO_001_00 seeking to alter the proposed zoning, additional permitted uses and vary zone boundaries for land at the former RAAF Stores Depot Palmer Street, Dubbo. It is noted that the components of the original planning proposal and Gateway Determination dated 24 February 2014 relating to Boundary Road, Whelers Lane and Darling Street remain.

I have determined as the delegate of the Minister for Planning, in accordance with section 56(7) of the Environmental Planning and Assessment Act, 1979, to alter the Gateway Determination dated 24 February 2014 and as altered on 13 August 2014 for Planning Proposal (PP_2014_DUBBO_001_00). Due to the nature of the requested alteration community and agency consultation is required in accordance with the original Gateway Determination dated 24 February 2014.

The timeframe to finalise the amending Local Environmental Plan is being extended by 6 months and is now due for completion by 2 March 2016.
