Joint Regional Planning Panel – Gateway Review – Recommendation Report

The Northern Joint Regional Planning Panel (JRPP) has considered the request for a review of the proposal as detailed below.

In considering the request, the JRPP has reviewed all relevant information provided as well as the views and position of the Department and the relevant local government authority. Based on this review the **JRPP recommends** the following:

Reason for Review: A determination has been made that the planning proposal should not proceed.

JRPP Advice and Justification for Recommendation:

The delay in resolving the E zones has created an inconsistency between the deferred areas of the 1987 LEP and the 2012 LEP.

It is noted that the approved 2012 LEP contains the provisions sought by Council for the areas currently subject to deferral.

Neither the Code of Practice governing private native forestry nor the Native Vegetation Act provide a specific requirement for a physical inspection to identify potential koala habitat and the habitat of other threatened species. It is the panel's understanding that the current code only requires a desktop survey.

Whilst it is advised that since 2007 there have only been seven (7) private native forestry Private Vegetation Plans issued, the panel is of the view that it is the significance of the

areas impacted that needs to be given more consideration than the actual number. Ballina Shire Council is characterised by limited forestry resource, both Crown and private.

It is acknowledged that a dual approval process will need to be followed, as is present in the 2012 LEP and is in keeping with the expectation of the Biodiversity Review. Whilst the PNF Code of Practice conditions and regulates construction and maintenance of forestry infrastructure it does not condition or regulate private native forest activities in relation to offsite impacts; for example, erosion and sediment control. Further, the Biodiversity Review should also consider strengthening the Code of Practice for PNF to ensure a physical site inspection is required by the consent authority and the addition of conditions in a PVP regulating offsite environmental impacts.

The panel accepts the advice that there is a process underway for the Northern Councils' review of environmental zones and the Government's review of the biodiversity legislation. The panel has no clear advice as to the potential timing or resolution of these reviews.
