Abstract : A report which presents and analyses mortal remains interment, cremation and ash interment activity completed in NSW in 2014/15. CCNSW has surveyed operators of all active NSW facilities, including 49 crematoria and 851 cemeteries, in respect of burial, second and renewable burial, cremation, and ash interment and scattering activity for 2014/15. This report presents and analyses the activity information provided by NSW operators. The report is expected to be of value in evidencing current practices, in supporting the CCNSW greater metropolitan cemetery capacity analysis work which follows in 2016, and in maintaining industry awareness of the operational and demographic contexts of cemetery and crematorium facilities.

### **Message from the Chair**



On behalf of the Board, I am very pleased to present the Cemeteries and Crematoria NSW 2014-15 Activity Report.

Recently Cemeteries and Crematoria NSW developed and published a Strategic Plan, which sets the blueprint for the next five years. It describes how we will work collaboratively with our partners to meet ongoing challenges and ensure the communities of NSW have respectful, accessible, consistent and affordable burial and cremation services.

Cemeteries and crematoria are critical community infrastructure and provide essential services to the people of NSW. Among the serious challenges facing the interment industry is the growing awareness that cemetery space in the Greater Sydney area is fast running out. There

are other centres in regional NSW where similar cemetery capacity challenges are present, some where urgent action to plan and provide for future capacity for those communities is required.

Among other functions, the Cemeteries Agency was established to collect information about cemetery capacity and usage, future cemetery needs, and cemetery and crematorium performance, and to use the evidence to identify planning and policy issues, and to work with industry to develop and implement collaborative, sustainable solutions. CCNSW carries forward the Government's commitment to recognise and take account of the right of all individuals in NSW to a dignified interment and the treatment of their remains with respect.

Annual activity reporting on cremation and interment services provided in all regions of NSW and by all sectors of industry, and the associated information on the consumption of cemetery land, provides essential evidentiary material to inform planning for the future provision of service capacity for the community of NSW.

The 2014/15 cemeteries and crematoria report includes information in respect of 900 facilities, including 49 crematoria and 851 cemeteries, as reported by industry operators. I wish to acknowledge and thank the many cemetery and crematorium operators in NSW who have committed time and effort to providing the activity information on which the Activity Report is based.

The Report identifies cremation rates and rates of consumption of new grave plots for all planning regions of NSW. The analysis also identifies many differences between regions, reflecting the different circumstances faced by operators, and different orientations and different service access opportunities for community members. I hope that NSW cemetery and crematorium operators find in the report information of value to their current delivery of services, and to their planning of services to be required in the years ahead.

I look forward to activity reporting for future periods, so that evidence on the trends which are material to future service requirements can be monitored. With the projected increase in deaths per annum in NSW over coming decades, updated information on metropolitan and regional cremation rates, and the take-up of renewable interment rights, will be of particular value.

### 1. Executive Summary

New South Wales has a long history of setting aside significant areas of land for public cemeteries to ensure that the right to a dignified burial is afforded to all members of the community. NSW is also unique among Australian jurisdictions with its mix of Crown, local government and private cemetery sectors.

In 2012 the NSW Government commenced a program of reforms to bring a coordinated, strategic approach to management of the interment industry, to address the critical shortage of burial space and to ensure the full range of interment options is accessible and affordable to everyone. The reforms provided for the *Cemeteries and Crematoria Act 2013*, and the establishment of Cemeteries and Crematoria NSW (CCNSW), an agency with functions including to collect information about cemetery capacity and needs, usage and performance; and to deliver evidence from which to identify planning and policy issues, and develop and implement collaborative, sustainable solutions.

The CCNSW 2014/15 activity survey sourced activity information from cemetery and crematoria operators state-wide, in respect of burial, second and renewable burial, cremation, and ash interment, including information in respect of 900 facilities, including 49 crematoria and 851 cemeteries. The following table represents 2014/15 mortal remains interment and cremation activity reported for all Planning Regions in NSW:






Sector % of total NSW services (53,945)

#### No. of deaths v No. of interment services


- » Whole of NSW a net incoming traffic to NSW for burial and cremation services (53,945 burials and cremations in 2014/15, compared with 52,320 deaths recorded for 2014, a difference of +1,625 or +3.1%)<sup>3</sup>
- » Deaths: estimated populations of metropolitan and regional NSW as at 2014 were Metro 4,509,579 (60%), and rural and regional 3,008,893 (40%); deaths recorded for 2014 were Sydney 24,919 (47.7%) and regions 27,243 (52.3%), reflecting the difference in age profiles between Sydney and regional communities
- Metropolitan Sydney a net incoming traffic to Metropolitan Sydney for burial services (25,938 burials and cremations for 2014/15, compared with 24,919 deaths for 2014, a difference of +1,019 or +4.1%)
- » NSW excluding Sydney a net incoming traffic to regional NSW for services (28,007 burials and cremations for 2014/15, compared with 27,401 deaths for 2014, a difference of +606 or +2.2%)

#### Distribution of services by sector


- Private sector operators provide the majority (55.7%) of primary services in NSW, delivering 30,049 primary services, comprising 2,845 burials and 27,204 cremations
- Private sector operators provide 75% of cremation services in NSW, including 69% of metropolitan area cremations (11,821), and 81% of regional cremations (15,383)
- Councils provide 22.7% of overall services; the largest share of all burials in NSW (8,736, or 49% of NSW burials), and the great majority of regional burial services (7,840, or 86% of regional burials)


Sector % of Sydney Metro services (25,398)

 Crown Trusts provide 21.3% of primary services in NSW, but provide the great majority of metropolitan burial services (5,984, or 69% of metropolitan burials)

#### **Cremation rates**

- » the Sydney cremation rate (66.3%) is consistent with the rest of NSW (66.9%); given proximity constraints in the regions, the rate likely reflects an orientation to burial for many communities in greater Sydney
- a much higher level of cremation is current in the Central Coast, Hunter and Illawarra<sup>4</sup> regions (78.8%)
- » the number of cremations for 2014/15 is considerably higher than 2013 (+2,288) and suggests an increase in the state-wide cremation rate of 1.4% from 65.3% to 66.9%
- » it will be of particular interest in 2015/16 whether an ongoing trend toward cremation is in effect

#### **Burials per cemetery**


» there is great variance in burial rates per cemetery between metropolitan and regional areas; for Sydney the average is 153 burials per cemetery for 57 active cemeteries; for the remainder of the state excluding Sydney, 11 burials per cemetery for 794 active cemeteries

#### Second interments and occupancy rates


- » in the metropolitan area, where cemetery space is at a premium, the rate of second or subsequent interment is 30.3% of all burials, suggesting a 'current' grave occupancy rate of 1.45
- the figures identify that metropolitan cemetery space is being consumed with relative efficiency, and the occupancy rate is expected to increase in future years

### Rate of cemetery land consumption in Metropolitan Sydney

- » CCNSW calculates that as at 1 Jan 2015 there were around 310,000-330,000 grave plots available for new interments in Metropolitan Sydney
- » there were 6,013 interments in new graves in Sydney in 2014/15, with around 2% of available stock consumed for interments; steep increases in deaths per annum in future years will greatly increase the rate.


### Importance to greater Sydney of West-Central region facilities

- strategic' facilities in the West-Central region of Sydney, including Rookwood, Pinegrove and Castlebrook facilities currently service much of the greater Sydney community
- » the region sustains 29.7% of the metropolitan population, but provides 40.3% of primary services (burials and cremations) and 54.6% of greater Sydney burials

### Interment and memorialisation following cremation

- » 2013 activity data identified the interment of 30,498 remains in NSW cemeteries (17,968 burials and 12,530 ash interments), 60.7% of deaths recorded in NSW for the period
- » 2014/15 data identifies the disposition of 29,951 remains in NSW cemeteries (17,853 burials and 11,738 ash interments or scatterings), 57.4% of deaths recorded in NSW for the period
- » the Metropolitan Sydney 'share' of reduced ash interments (approx. 80% of the reduced total) is much higher than the metropolitan 'share' of ~50% of total services provided

 regional Councils report a rate of ash interment or ash scattering to 80.5% of cremation services provided (however the rate of ash interment will include interment of ashes cremated by other operators)

#### Looking ahead

The relatively low cremation rate for the heavily populated Sydney region, by comparison with adjoining Hunter, Central Coast and Illawarra region cremation rates, suggests a continued orientation to burial for many Sydney communities. The cremation rate for Sydney will be material to the cemetery capacity which is required for the Sydney population in future decades. CCNSW intends to publish a Greater Sydney cemetery capacity report later in 2016, including sensitivity testing in respect of the future Sydney cremation rate, and effect upon cemetery land consumption.

It will be of particular interest in 2015/16 whether an ongoing trend toward cremation is in effect, given the effect of the variable to increasing deaths per annum and long term cemetery land requirements.

Further reporting in future periods by cemetery and crematoria operators will provide visibility of increased interment volumes and efficiency of cemetery land use in the years ahead, as annual mortality volumes double between 2011 and 2051. Activity reporting will provide an evidence base of actual rates of cremation, mortal remains interment, and second and subsequent interments, to inform planning for future community infrastructure requirements.

## 2. Background and context

Cemeteries and crematoria are critical community infrastructure and provide essential services to the people of NSW. They are vital places for remembrance and reflection, a rich source of cultural and environmental heritage and provide valuable open spaces. The rich diversity of our community means there are a wide range of needs and expectations for burial and cremation services. Information compiled by Multicultural NSW shows that NSW is home to 200+ languages, 125+ religions, and some 300 ancestries.

There are over 50,000 deaths a year in NSW, and associated burial and cremation services, with many more cremations than burials overall.

#### Cemetery and crematorium operators in NSW

Over 230 cemetery and crematorium operators provide interment services across NSW. Service providers active in NSW include:

**Crown trusts:** four large trusts in Sydney; five smaller trusts in regional NSW; Crown trusts conduct around 70 per cent of burials in Sydney

**Local Councils:** Councils manage around 950 cemeteries in NSW; 80 per cent of council-run cemeteries are closed or conduct 10 or fewer burials per year; Councils manage 8 crematoria in NSW; and conduct around 50 per cent of burials in NSW and 10 per cent of burials in Sydney

**Private operators:** private operators manage over 70 per cent of crematoria in NSW; manage around 2 per cent of cemeteries in NSW; and conduct 75 per cent of cremations in NSW

**Community operators:** community operators oversee many small, closed cemeteries; manage around 10 per cent of operational cemeteries in NSW; and conduct around one per cent of burials and no cremations.

#### **Cemeteries and Crematoria NSW**

Cemeteries and Crematoria NSW (CCNSW) is the statutory body with strategic and regulatory oversight of the interment industry and responsibility for administering the *Cemeteries and Crematoria Act 2013*.

CCNSW is led by an independent expertise-based board responsible to the Minister for Primary Industries (DPI), the Hon Niall Blair MLC. The Board is Chaired by Dr Stepan Kerkyasharian AO, former Chair and CEO of Multicultural NSW. A specialist business unit of DPI employees, led by CEO Carl Malmberg, supports the Board and enables CCNSW to carry out its functions. The Agency was established to collect information about cemetery capacity and usage, future cemetery needs, and cemetery and crematorium performance, to use the evidence to identify planning and policy issues and develop and implement collaborative, sustainable solutions. CCNSW carries forward the Government's commitment to recognise and take account of the right of all individuals to a dignified interment and the treatment of their remains with respect. This includes ensuring that the beliefs of all community groups are respected and equitable and affordable access to interment services is adequately provided, irrespective of religious or cultural heritage. CCNSW has prepared a Strategic Plan for 2015-2020, to articulate our role and priorities to the community and industry partners<sup>5</sup>. It describes how CCNSW will deliver the NSW Government's commitment to ensuring community needs and expectations are met. The plan also sets out a blueprint for implementing the new regulatory framework for the interment industry. CCNSW is responsible for ensuring that planning and acquisition of cemetery capacity sufficient to provide for the needs of the NSW population and communities is carried forward, and land acquired as necessary to meet the service needs of communities.

Population and mortality project data developed by the NSW Department of Planning and Environment projects that the number of persons who die each year in NSW will increase from around 50,160 in 2011 to 73,270 by 2041 (+46%)<sup>6</sup>. In the greater metropolitan area, including Metropolitan Sydney, Hunter, Central Coast and Illawarra regions, the number of persons who die each year is projected to increase from around 35,390 per annum in 2011 to 53,070 per annum by 2041 (+50%).

The last substantive survey of cemetery capacity in the greater Sydney region completed in 2002-2005, projected exhaustion of available cemetery capacity in the Sydney Metropolitan area before 2050. Some population centres in regional NSW are also understood to be approaching exhaustion of cemetery capacity.

CCNSW is currently completing a refreshed survey of cemetery capacity available within metropolitan Sydney, and of the service needs of the diverse metropolitan community. These surveys will provide an evidence base for planning and securing the cemetery and crematoria facilities which will be required in coming decades. In 2016 and 2017 CCNSW plans to extend survey work to regional areas, to identify where future cemetery capacity is at risk, so that appropriate actions in planning and securing land for cemetery usage may be carried forward.

## CCNSW 2014/15 cemeteries and crematoria operator activity survey

The activity survey completed with NSW cemetery and crematorium operators for the 2014/15 financial year was completed in order to contribute to the evidence base for planning for future service and cemetery space requirements. The objects of the *Cemeteries and Crematoria Act 2013* include objects

- (c) to ensure that sufficient land is acquired and allocated so that current and future generations have equitable access to interment services;
- (d) to provide for the operation of a consistent and coherent regime for the governance and regulation of cemeteries and crematoria;
- (e) to ensure that the operators of cemeteries and crematoria demonstrate satisfactory levels of accountability, transparency and integrity; and
- (g) to promote environmental sustainability of the interment industry, including provision for natural and private burial.

Part 4 of the Act, upon commencement, will establish a consistent regime of interment rights for NSW cemeteries, including a regime for renewable interment rights. Implementation of renewable interment rights will be an option available to cemetery operators, which is expected to have the effect of increasing the efficiency of cemetery land usage, by allowing for increased numbers of

interments in individual grave plots<sup>7</sup>. With the view to tracking the efficiency of grave plot use in future, the 2014/15 activity survey included sourcing from operators information in respect of the number of interments of bodily remains in perpetual interment sites **in which one or more previous interments had taken place** (ie where an existing grave was re-opened).

It is intended that annual activity reporting by cemetery and crematoria operators be continued, to provide for visibility of increased mortality volumes and efficiency of cemetery land use in the years ahead as annual mortality volumes are projected to double between 2011 and 2051. Activity reporting will provide an evidence base of actual rates of cremation, mortal remains interment, and second and subsequent interments, to inform planning for future community infrastructure requirements.

# History of cemetery and crematorium activity reporting in NSW

Visibility of whole-of-industry annual activity volumes for NSW cemeteries and crematoria prior to 2014 was reliant upon occasional sampling performed with major facility operators<sup>8</sup>. There is some private sector research on the aggregate industry sector of funeral directors, crematoria and cemeteries nationally, which does not report on service activity volumes, or by jurisdiction<sup>9</sup>.

To assist in communications with industry participants upon implementation of the *Cemeteries* and *Crematoria Act 2013*, the DPI Cemetery Reform Group (CRG) completed a process to register cemetery and crematorium facilities during 2014, with registration forms requiring reporting of 2013 interment service activity. Activity information captured was used to plan the forward work program for the CCNSW entity, but was not published as a representation of 2013 industry activity.

During 2014, the CRG and then CCNSW continued compilation of a Cemeteries and Crematoria Register, targeting registration of all currently operating cemetery and crematorium facilities in NSW. From July 2015, CCNSW performed a refreshed and more comprehensive activity survey, sourcing activity volumes and related estimates for cemetery and crematorium services performed in 2014/15, for all operators and facilities registered as 'operational' on the CCNSW Cemeteries and Crematoria Register.

#### Approach to the 2014/15 activity survey

The CCNSW 2014/15 activity survey refined the data required from operators, to allow better tracking of grave plot consumption, and was supported by follow-up with operators where questions presented over data completeness or accuracy.

The 2014/15 NSW cemeteries and crematoria activity survey relies on four primary data inputs;

- » Use of NSW Government projections of population and mortality by local government area
- » Use of the CCNSW Cemeteries and Crematoria Register, to identify facilities and contacts for sourcing of activity information
- » Use of cemetery operator activity survey information captured for the 2013 year, as a sensecheck on 2014-15 activity data provided by operators
- » Use of 2014-15 cemetery operator cemeteries and crematoria activity information, sourced from operators between July and September 2015.

Activity survey information captured from operators includes information in respect of 900 facilities, including 49 crematoria and 851 cemeteries. The work commenced with CCNSW review of the 2013 survey data, and framing of data and methodology parameters for the revised survey, and the issue of survey information and data collection forms. CCNSW liaised with operators to assist in correction of registration data, and to clarify data types and associated definitions, as necessary. Where activity information received to CCNSW was unclear, or significantly different from indicative data collected in 2013, CCNSW followed up with operators to confirm the reliability of activity information recorded.

## 3. Purpose and Scope

Given projected population increases through to 2056, and associated increases in deaths per annum, additional facilities and additional cemetery capacity will be required in NSW to provide the services required by the NSW community.

Many of the operational cemeteries in NSW were established in the 19th and early 20th centuries. While a number of private cemeteries established in greater Sydney later in the 20th century, the last major commitment of land to Crown cemetery usage in greater Sydney was in 1937. A review of cemetery capacity available in greater metropolitan Sydney was last completed in 2002-05, and identified that cemetery capacity may be exhausted by 2050 if not before<sup>10</sup>.

Annual activity reporting on cremation and interment services provided in all regions of NSW and by all sectors of industry, and the associated information on the consumption of cemetery land, provides essential evidentiary material to inform planning for the future provision of service capacity for the community of NSW.

Strategic review of community needs in relation to burial and cremation, and remaining cemetery capacity, is increasingly a function performed by Governments in Australia. In Victoria the Cemeteries and Crematoria Regulation Unit published a report estimating the remaining capacity of Victorian cemeteries in 2012<sup>11</sup>, and a number of NSW Councils active as the primary service provider for their communities have undertaken cemetery strategic planning in recent years<sup>12</sup>.

To avoid disclosure of individual operator activity information, data capture and analysis is premised on bundling to NSW Government planning regions <sup>13</sup>, and includes the following planning regions and local government areas:





Chart 3.1 NSW planning regions and Local Government Areas, rural and regional NSW

#### 4.1 Review of NSW Register of Cemeteries and Crematoria data

The NSW Cemeteries and Crematoria Register is maintained by CCNSW in accordance with Section 27 of the *Cemeteries and Crematoria Act 2013*. The purpose of the Register is to provide for ready public access to information about cemetery and crematorium facilities in NSW, and to identify cemetery and crematorium operators subject to the Act and Regulations. A public version of the register is made available at:

http://www.dpi.nsw.gov.au/lands/cemeteries-crematoria/register-extract#cemeteries.

Operators are required to notify CCNSW of information for inclusion in the Register, including:

(a) the name and location of the cemetery or crematorium,

(b) the name and address and telephone number of the cemetery or the crematorium and operator, and

(c) any other information required by the regulations to be included in the Register.

CCNSW work with NSW cemetery and crematorium operators is focussed on operational facilities, which are the focus of the *Cemeteries and Crematoria Act 2013*. Other resources are available for identification of closed cemeteries and other burial places in NSW<sup>14</sup>. Approximately half of all deaths per annum in NSW are in Metropolitan Sydney, and half in rural and regional NSW. In the regions, the great majority of cemetery facilities are operated by Councils, in the absence of other market participants. Cremation services in regions are provided by private operators and by Councils, with distribution of facilities generally to regional towns with a 'critical mass' of population and service demand.

The following tables summarise data maintained in the Register in respect of operational cemeteries and crematoria as at November 2015.



#### 4.2 Review of Activity Survey parameters

As above, an initial interment services activity survey was completed in 2013, in association with compilation of the Register. The survey sought activity information from operators including

- » No of interments (2013) bodily remains
- » No of interments (2013) cremated remains
- » No of cremations (2013).

The data provides a valuable snapshot of interment practices across the state for the calendar year, and provides a measure for changes in interment choices in years ahead.

#### **Renewable interment rights**

CCNSW is responsible for coordinating implementation of the *Cemeteries and Crematoria Act 2013*, which provides for strategic oversight and regulation of the interment industry for the first time in NSW. Implementation work scheduled for 2016 includes commencement of Part 4 of the Act, which establishes a consistent regime of interment rights for all cemeteries in NSW. Provisions of Part 4 include standard statutory rights in respect of perpetual interments of mortal remains, and commence a statutory regime of renewable interment rights for interments of mortal remains.

The CCNSW Strategic Plan includes priority work streams to ensure that all people in NSW have access to a range of interment services that preserve dignity and respect and support cultural diversity, and to ensure that sufficient and suitable land is available to meet future demand for interment services.

Supporting increased efficiency of the use of cemetery land, including through renewable interments and double or second interments, is a priority for the Cemeteries agency. Given the majority practice of cremation in NSW, monitoring and providing support for practices for interment of ashes, scattering of ashes, and cremation memorialisation, is also a priority. Reporting on rates and practices for ash disposition will contribute to the preservation of dignity and respect for deceased community members and their families.

#### Whole of state information

NSW is unique among Australian jurisdictions with its mix of Crown, local government and private cemetery sectors. Cemeteries and crematoria across NSW are independently managed by State agencies, local government, public and religious trusts, community and other organisations, and private companies. To develop and implement a comprehensive, coherent and cohesive evidence-based strategy for the State's interment industry, access to accurate, reliable and consistent data from all three industry sectors is required.

Awareness of services and activity levels across all sectors and regions will assist CCNSW in effectively supporting the implementation of Part 4 with operators state-wide, so that the benefits of a consistent regime of interment rights may be efficiently realised.

#### **Revised data parameters**

To provide for visibility of the current and future rate of take-up of renewable interment rights, to allow identification of current and future rates of second burials in existing graves, and to better follow developing arrangements in the disposition of cremated remains in cemeteries, the 2014/15 activity survey sought activity information from operators including

- » Number of interments of bodily remains in new perpetual interments sites (ie, gravesites that had no previous interments)
- » Number of interments of bodily remains in perpetual interment sites in which one or more previous interments had taken place (ie where an existing grave was re-opened)
- » Number of interments of bodily remains in interment sites under renewable rights terms
- » Number of interments of cremated remains below ground or in a niche wall / columbarium
- » Number of cremated remains scattered within grounds.

Information received in relation to these parameters allows tracking of burial and cremation trends, take-up of renewable interment rights, efficiency of grave plot usage, trends in the disposition of cremated remains, and analysis and projection of future cemetery land requirements.

# 4.3 Review of NSW cemeteries and crematoria activity survey response data

Response information received from operators was reviewed by CCNSW, and followed-up, with further enquiries as necessary. Response information as reviewed for completeness and consistency with prior year information, and for updated information for inclusion to the Register.

#### **Completeness of response information**

As above, an initial NSW interment services activity survey was completed in 2013.

Comparable activity data captured for 2013 included cremation and interment services performed or estimated to have been performed by operators in that year. The original 2013 survey collected data from 691 operational cemeteries and 44 crematoria, managed by 124 cemetery operators and 17 crematorium operators, as registered by DPI to October 2014. Additional facilities registered through to November 2015 have provided additional 2013 activity information. The total number of primary burial and cremation services reported for 2013 is 51,792. This figure compares with 50,237 deaths reported in NSW in 2013 by the ABS<sup>15</sup>. The activity figure is slightly higher than the no. of reported deaths, and indicates the activity data is close to complete.

The 2014/15 activity survey includes data provided by 851 operational cemeteries and 49 crematoria, managed by 228 cemetery and crematorium operators. Activity data identifies 53,945 primary burial and cremation services provided in 2014/15. This figure compares with 52,162 deaths reported in NSW in 2014 by the ABS. The activity figure is higher than the no. of reported deaths for 2014, and higher than the 2013 total no. of services provided. Again, the figure indicates the 2014/15 activity data is very close to complete.

#### Consistency and accuracy of survey response information

As above, for the 2014/15 survey CCNSW collected data from 900 facilities managed by 228 operators, as registered to November 2015.

Activity survey responses received from operators were reviewed for identification of updates required to the Register, for logical consistency, and to identify activity volume changes from 2013 of such quantum as to warrant confirmation. Given the high no. of facilities for which reports were due, and the new categories of information included in the 2014/15 survey, a moderate volume of follow-up enquiries were required to confirm data for inclusion to the analysis. Not all cemetery operators maintain systems which readily differentiate an interment as a 'second interment', so it is likely that aggregate data for the state slightly under represents 'second interments', these being treated as first interments where system constraints applied. Inclusion for the first time of the interment type 1.3 'interments under renewable rights terms' also led to some inaccuracies, with this category requiring a volume of explanation and data correction.

While CCNSW continues to liaise with a small number of operators in respect of 2014/15 activity data, potential variations subsequent to November 2015 are not expected to be material to the analysis or findings.

# 4.4 Analysis of the number of deaths and interment services in 2014/15

2014/15 activity information reported represents 103.1% of deaths recorded in NSW in 2014, indicative of a level of incoming traffic received to facilities in NSW for interment and cremation services.

The following table represents 2014/15 mortal remains interment and cremation activity reported for all Planning Regions in NSW, and for Sydney Metropolitan, Rural and Regional NSW, and Central Coast, Hunter and Illawarra subsets of NSW:





Chart 4.2 Services within region as a % of deaths within region  $\,$  - rural and regional planning regions

#### Analysis:

Points of interest arising from the 2014/15 total services activity information include

- » Deaths: the estimated resident populations of metropolitan and regional NSW as at 2014 were Sydney Metropolitan 4,509,579 (60%), and rural and regional 3,008,893 (40%)<sup>20</sup>. Deaths recorded for 2014 were Sydney Metropolitan 24,919 (47.7%), and rural and regional 27,243 (52.3%), reflecting the difference in age profiles between metropolitan and rural regions<sup>21</sup>.
- » Total no. of services: the number of primary services provided (+53,945) is higher than the no. of reported deaths in NSW (+52,162), suggesting the 2014/15 activity data is very close to complete, and indicating a rate of 'traffic' incoming to NSW for cemetery and cremation services
- » No. and rate of burials: the no. and rate of burials is largely consistent between Sydney Metropolitan and Rural and regional NSW, burials representing 35% of deaths in Sydney and 33.4% of deaths in Rural and regional NSW
- » No. and rate of cremations: the cremation rate is largely consistent between Sydney Metropolitan and Rural and regional NSW, between 66-67%; but a much higher level of cremation is current in the Central Coast, Hunter and Illawarra regions<sup>22</sup> (78.8%)
- » No. and rate of ash interments: data on ash scatterings is known to be incomplete<sup>23</sup>; but data for ash interments within cemeteries indicates a higher rate of interment and memorialisation in Sydney (37.4%) than for Rural and regional NSW (28%).

### 4.4.1 Analysis of 2014/15 metropolitan and regional interment services by sector

Over 230 operators provide interment services across NSW. Types of operators providing services in NSW include:

#### Crown trusts

- » five large trusts in Sydney
- » five smaller trusts in regional NSW
- » Crown trusts conduct around 70 per cent of burials in Sydney.

#### **Private operators**

- » manage over 70 per cent of crematoria in NSW
- » manage around 2 per cent of cemeteries in NSW
- » conduct ~75 per cent of cremations in NSW.

#### **Local Councils**

- » manage around 950 cemeteries in NSW
- » 80 per cent of council-run cemeteries are closed or conduct 10 or fewer burials per year
- » manage 8 crematoria in NSW (all are outside Sydney Metro)
- » conduct around 50 per cent of burials in NSW, and only 10 per cent of burials in Sydney

#### **Community operators**

- » oversee small, closed cemeteries
- » are typically local communities and religious entities
- » manage around 10 per cent of operational cemeteries in NSW
- » conduct around one per cent of burials across NSW and no cremations.




Chart 4.4 Burial and cremation services in NSW by operator sector

The figure is derived by dividing the number of burials completed in the term by the number of burials in new plots completed for the term. The figures must be used with caution, as at the cemetery-specific level, as a cemetery facility nears exhaustion of capacity, only second or subsequent interments may be completed, and the apparent occupancy rate may exceed 2 per grave. CCNSW considers that grave occupancy rate is of value at the regional level, where variations between facilities net out, and where facility-specific anomalies may be excluded from analysis. In specific cases where a single facility volume predominates, the apparent rate of grave occupancy may be deemed unreliable.







Chart 4.6 Distribution of Total Burials and Cremation Services Across NSW - Metropolitan Sydney






Chart 4.7 Cremation Rate by Region - rural and regional planning regions

Points of interest arising from the 2014/15 metropolitan and regional burial services activity by sector information include

#### Distribution of services by sector:

- » Private sector operators provide the majority (55.7%) of primary services in NSW, delivering 30,049 primary services, comprising 2,845 burials and 27,204 cremations
- Councils provide 22.7% of primary services in NSW, but provide the largest share of all burials in NSW (8,736, or 49% of NSW burials), and the great majority of regional burial services (7,840, or 86% of regional burials)
- » Crown Trusts provide 21.3% of primary services in NSW, but provide the great majority of metropolitan burial services (5,984, or 69% of metropolitan burials)
- » Church and community operators maintain 109 cemeteries which reported burial or ash interment activity for 2014/15, which included 126 burials, 86 of these in regional NSW.

#### Sydney Metropolitan v rural and regional NSW:

- » No. of burials: the no. of burials is similar between Sydney Metropolitan and Rural and regional NSW, with 8,730 burials in the metropolitan area, and 9,103 burials in regional NSW
- » Burials in new graves: burials in new graves still represent a majority of burial activity, at 6,013 of 8,730 burials in metropolitan areas (68.8%), and at 6,711 of 9,103 in regional NSW (73.7%)
- » Second interments and occupancy rates:
  - In the metropolitan area, where cemetery space is at a premium, the rate of second or subsequent interment is 30.3% of all burials, suggesting a 'current' grave occupancy rate of 1.45.
  - > The figures identify that metropolitan cemetery space is being consumed with relative efficiency, and the occupancy rate is expected to increase in future years.
  - > In regional NSW where there is generally less pressure on cemetery space, the rate of second or subsequent interment is 26.3%, suggesting a grave occupancy rate of 1.36.
  - > If known high rates of second interment at some Hunter and Central Coast cemeteries are excluded, the regional occupancy rate is around 1.3.

#### Crown and Council operators v Private sector:

- » Share of burials: in the metropolitan area Crown trusts provide 69% of all burial services, while in regional NSW, Council operators provide 86% of burial services; conversely, private sector operators provide 21% of metropolitan burial services and 11% of regional burial services
- » Second interments and occupancy rates;
  - > Crown cemeteries reported the highest rate of second or subsequent interments (35.5%), reflecting their focus on metropolitan burials, and the premium on space
  - Councils cemeteries reported the next highest rate of second or subsequent interments (25.5%), reflecting an efficient approach to interment land use for burial focused cemeteries
  - > Private sector and church/community operators reported lower second interment rates (private sector 22%; church/community 11.1%).

### 4.4.3 Analysis of 2014/15 metropolitan and regional cremation and ash disposition by sector

The following table represents 2014/15 cremation and ash disposition activity reported for NSW, grouped by whole of NSW; and Sydney Metropolitan; Rural and Regional NSW; and Central Coast, Hunter and Illawarra subsets of NSW:




Chart 4.8 NSW 2014/15 Ash disposition as % of cremations performed

Limited response information as received, and the no. of ashes reported as scattered is considered substantively incomplete.

Points of interest arising from the 2014/15 metropolitan and regional cremation and ash disposition activity by sector information include:

#### Sydney Metropolitan v rural and regional NSW:

 Cremation rate: the cremation rate is similar between Sydney Metropolitan and rural and regional NSW, with 17,208 cremations in the metropolitan area (at 66.3%), and 18,904 in regional NSW (at 67.5%)

#### Distribution of cremation services by sector:

- » Private sector operators provide 75% of cremation services in NSW, including 69% of metropolitan area cremations (11,821), and 81% of regional cremations (15,383)
- Council operators provide 10% of cremation services in NSW, all of these in regional areas (19% of regional cremations)
- » Crown Trusts provide 15% of cremation services in NSW, all of these in the metropolitan area (31% of metropolitan cremations)
- » no church and community operators provide cremations.

#### Interment of ashes by sector and region:

- » data for ash interments within cemeteries indicates a higher rate of ash interment and memorialisation in the metropolitan area (37.4%) than for rural and regional NSW (28%)
- » given 17,208 cremations in the metropolitan area, there were 3,180 ash interments in cemeteries, and 492 recorded ash scatterings, accounting for 37.4% of metropolitan cremations
- » Crown cemetery survey responses represent a rate of ash interment or ash scattering to 51.3% of cremation services provided (all but one of the major Crown facilities are in the metropolitan area; and ash interments will include interment of ashes cremated by other operators<sup>28</sup>)
- » given 18,904 cremations in regional NSW, there were 5,140 ash interments in cemeteries, and 154 recorded ash scatterings, accounting for 28% of regional cremations
- » regional Council survey responses represent a rate of ash interment or ash scattering to 80.5% of cremation services provided (NB, the great majority of regional cemeteries are Council operated, and the rate of ash interment will include interment of ashes cremated by other operators).

28 NB, activity survey responses did not ask operators to associate cremation services provided with ash interment services provided at an individual service level; in Table 4.5 - NSW 2014/15 Metropolitan v Rural & Regional cremation and ash disposition activity by Sector the rate of 'ash disposition' includes interments of ashes (in a columbarium, niche wall or in the ground) and recorded scattering of ashes within a cemetery. The 'Ash disposition rate' reflects net volumes of ashes interred and scattered with the reporting period, compared with cremation services provided in the reporting period.

## 4.5 Comparison of 2014/15 metropolitan and regional interment services with 2013 data

As described above, in 2013 the DPI Cemetery Reform Group completed a process to register cemetery and crematoria facilities during 2014, with registration forms requiring reporting of 2013 interment service activity. Activity information captured was accepted as reported and was not subject to a process of quality assurance and confirmation. Comparison with the 2014/15 activity data suggests the 2013 activity report is reasonably complete and reasonably accurate. Nonetheless, while differences between 2013 and 2014/15 activity data are quantified below for illustration, differences are indicative rather than confirming assured trends in burial and cremation activity.

Summary 2014/15 activity for all Planning Regions in NSW, and for Sydney Metropolitan, Rural and Regional NSW, and Central Coast, Hunter and Illawarra subsets of NSW, is as follows:

Calendar year 2013 activity information current to November 2015 identifies 17,968 mortal remains interments and 33,824 cremation services, a total of 51,792 primary services. The data also identifies 12,530 ash interments in cemeteries and memorial gardens subsequent to cremations. Data was not collected for ashes scattered in cemeteries. The rate of ash interment at cemeteries state-wide following cremation was 37%.

The 2014/15 activity information identifies 17,833 mortal remains interments, including 12,724 'first interments' in new graves, and 5,039 second or subsequent interments in existing graves; and 70 burials under existing renewable rights terms. A total of 36,112 cremation services were provided, to a total of 53,945 primary services. The data also identifies 11,738 ash interments or scatterings in cemeteries and memorial gardens subsequent to cremations. The rate of ash disposition at cemeteries state-wide following cremation was 32.5%.

#### 4.5.1 Comparison between years - for whole of NSW

Points of interest arising from the comparison between years for 2014/15 state-wide total services activity information include

- » No. of deaths: the increase in the number of deaths (+1,925, or 3.8%) is significant, and is consistent with the per-annum increases projected by the NSW Government through to 2021 (higher increases follow)
- » No. of services: the increase in the number of primary services provided (+2,153) is consistent with the increase in the no. of reported deaths in NSW (+1,925)
- » No. of burials: the no. of burials was down slightly (-85) against the 2013 figure, and aligns with a slight increase in the cremation rate
- » No. and rate of cremations: the no. of cremations is considerably higher than 2013 (+2,288) and represents an increase in the state-wide cremation rate from 65.3% to 66.9%
- » No. and rate of ash interments: 2014/15 data identifies 11,920 ash interments and 646 ash scatterings within cemeteries subsequent to cremations, noticeably down (-1,438) against 2013 data (by -4.5%, even where ashes formally scattered within cemeteries are included in 2014/15 figures).

#### 4.5.2 Comparison between years - Metropolitan Sydney

Points of interest arising from the comparison between years for 2014/15 Metropolitan Sydney total services activity information include

- » No. of services: the increase in the number of primary services provided (+771) is slightly higher than the increase in the no. of reported deaths in Metropolitan Sydney (+683)
- » No. of burials: the no. of burials was up slightly (+28) against the 2013 figure, indicating a persisting orientation to burial for many Sydney communities
- » No. and rate of cremations: the no. and rate of cremations increased in Sydney (+743 and +1.1%), but at a lower rate than the state-wide increase (+1.7%)
- » No. and rate of ash interments: the Metropolitan Sydney 'share' of reduced ash interments (approx. 80% of the reduced total) is much higher than the 'share' of ~50% of total services provided.

#### 4.5.3 Comparison between years - Rural and Regional NSW

Points of interest arising from the comparison between years for Rural and Regional total services activity information include:

- » No. of deaths: the increase in the number of regional NSW deaths (+1,242, or 4.7%) is significant, and reflects the higher representation of aged persons in regional NSW
- » No. of services: the increase in the number of primary services provided (+1,382) is higher than the increase in the no. of reported deaths, and likely reflects a level of incoming traffic to facilities adjoining Victoria and Queensland for interment and cremation services
- » No. of burials: the no. of burials was down (-163) consistent with the increased cremation rate
- » No. and rate of cremations: the no. and rate of regional cremations increased (+1,545 and +2.3%), partly realised by commissioning of new facilities (Bathurst and Tweed regions)
- » No. and rate of ash dispositions: the fall in regional ash dispositions (-127, or -3.2% to 28%) is less than the state-wide average fall, but commences from a low base (compare 43.2% ash interment rate for Metropolitan Sydney in 2013).

#### 4.5.4 Comparison between years - Central Coast, Hunter and Illawarra

Points of interest arising from the comparison between years for Central Coast, Hunter and Illawarra total services activity information include:

- No. of deaths: the increase in the number of Central Coast, Hunter and Illawarra deaths (+794, or 7%) is significant, and reflects the higher representation of aged persons outside Metropolitan Sydney
- » No. of services: the increase in the number of primary services provided (+774) is consistent with the increase in the no. of reported deaths
- » No. of burials: the number of burials (+143) is consistent with increases in deaths and cremation rate
- » No. and rate of cremations: the no. and rate of regional cremations increased (+631 and +0.2%)
- » No. and rate of ash dispositions: the fall in Central Coast, Hunter and Illawarra ash dispositions (-370, or -6.5% to 30.8%) is potentially concerning, if carried forward into future periods.

#### 4.5.5 Comparison between years - Ash disposition and memorialisation rates

Cremations represent 66.9% of all primary service activity in NSW, and the rate is understood to be increasing.

Legislation in NSW provides for the recording in cemetery registers of all burials and ash interments within cemeteries. For the 2013 survey, operators were asked to report on burials and on ash interment volumes. Data provided for 2013 identifies the interment of 30,498 remains in NSW cemeteries (17,968 burials and 12,530 ash interments), representing 60.7% of deaths recorded in NSW for the period.

Many cemeteries do not record ash scatterings, and the remains of many cremated persons are understood to be scattered informally, and at places of personal importance other than cemeteries, by community members. Data in respect of ash disposals generally is therefore known to be much less than complete. With the view to better identifying what happens to the other 39.3% of cremated remains (ie the volume of 21,294 cremations for 2013 for which no ash interment was reported), for the 2014/15 activity survey, operators were asked to report on ash interments and also on ash scatterings, where records were available.

Despite the inclusion in 2014/15 reporting of ashes officially scattered within cemeteries, the rate of ash interment and memorialisation following cremation appears to have fallen noticeably. For the 2014/15 period, the survey identifies the interment or scattering of 29,951 remains in NSW cemeteries (17,853 burials and 11,738 ash interments or scatterings), representing 57.4% of deaths recorded in NSW for the period.

Further work will be required with operators to confirm whether the apparent trend is consistent with industry experience, and whether any actions are feasible to increase memorialisation activity following cremations.

# 4.6 Analysis of the number of deaths and interment services by planning region in 2014/15

The following section analyses the cremation rate for each region , the 'net' volume of burial and cremation services provided in region, and considers the apparent rate of 'traffic' between regions for burial and cremation services in NSW, including an identified traffic to NSW for burial and cremation services.

As above, deaths by LGA data published by the ABS 2014 is used to represent the number of deaths in each NSW planning region, and to allow comparison with activity information from NSW operators. Not all deaths in a planning region are accommodated in that region. Some residents of the region will be buried or cremated outside the region and some residents of other regions are buried or cremated within the region. There is not a central register of addresses of deceased persons, so the identification of 'traffic' between regions is necessarily at the 'net' level, based on the difference between deaths and service provided within each region.

Burial and cremation data for 2014/15 for NSW by planning region and for Metropolitan Sydney by Sydney sub-region is detailed in the tables below.



Chart 4.9 Burials per cemetery - rural and regional planning regions








Chart 4.10 Burials per cemetery - Metropolitan Sydney

#### 4.6.1 Deaths and interment services by planning region, all of NSW

This section considers the 'net' volume of burial and cremation services provided, the apparent rate of 'traffic' to and between NSW planning regions for burial and cremation services, burials per crematory, and cremations per crematorium.

ABS deaths by LGA data is used to represent the number of deaths in each NSW planning region, and not all deaths in a planning region are accommodated in that region. The identification of 'traffic' between regions is necessarily at the 'net' level, based on the difference between deaths and service provided within each region. It is possible that a higher rate of traffic 'to' Sydney for burial or cremation services exists than is visible by review of the 'net' data provided.

Points of interest arising from review of the number of deaths and interment services by planning region for all of NSW include:

Services within region as % of deaths within region

- » Whole of NSW primary service activity volumes identify a net incoming traffic to NSW for burial and cremation services (53,945 burials and cremations conducted for 2014/15, compared with 52,320 deaths recorded for 2014, a difference of 1,625 or 3.1%)<sup>33</sup>
- » Metropolitan Sydney a net incoming traffic to Metropolitan Sydney for burial services (25,938 burials and cremations for 2014/15, compared with 24,919 deaths for 2014, a difference of 1,019 or 4.1%)
- » NSW excluding Sydney a net incoming traffic to regional NSW for services (28,007 burials and cremations for 2014/15, compared with 27,401 deaths for 2014, a difference of 606 or 2.2%)
- » Murray Murrumbidgee an incoming traffic from Victoria for burial and cremation services (3,929 services for 2014/15, compared with 2,206 deaths for 2014, a difference of 1,723 or 78.1%)

33 While the reporting period for deaths (2014) and services provided (2014/15) are not absolutely coincident, the no. of services provided is sufficiently higher than the no. of deaths expected to be recorded as to confirm a rate of traffic incoming to NSW for burial and cremation services.

- » North Coast and New England-North West an outgoing traffic from northern LGAs for burial and cremation services (7,366 services for 2014/15, compared with 7,882 deaths for 2014, an aggregate difference of -515 or -7%)
- » South East and Tablelands an outgoing traffic, presumed to Canberra (1,812 burials and cremations for 2014/15, compared with 2,262 deaths for 2014, a difference of -450 or -7%)
- » Other regions differences between the Central Coast and Hunter largely net out; in other regions variances appear not to be significant.

Burials per cemetery

- » Whole of NSW there is great variance in burial rates per cemetery between metropolitan and regional areas; for Sydney the average is 153 burials per cemetery for 57 operational cemeteries<sup>34</sup>; for the remainder of the state excluding Sydney, 11 burials per cemetery for 794 operational cemeteries
- » Metropolitan Sydney the total volume of burials in cemeteries in Sydney provides in-principle opportunity to operators for capture of revenues to fund ongoing maintenance of cemeteries
- » NSW excluding Sydney the rate of burials per cemetery outside Sydney makes clear the challenge for regional operators in capturing revenues sufficient to fund ongoing maintenance of cemeteries

Cremation rates

- » Whole of NSW & Metropolitan Sydney the cremation rate for Sydney (66.3%) is consistent with that for the rest of NSW (66.9%); although given proximity constraints to crematoria in many parts of the state, the rate likely reflects an orientation to burial for many communities in the Sydney population
- » Hunter, Central Coast and Illawarra the cremation rates for Hunter, Central Coast and Illawarra (78.6%, 83.6% and 74.9%) are well above the state average (66.9%)
- » Other regions with lower cremation rates are likely affected by logistical constraints and costs where access to a local crematorium is not available

Cremations per crematorium

- Whole of NSW again considerable difference in cremations per crematorium between metropolitan and regional areas; for Sydney the average is 1,434 cremations per crematorium for 12 crematoria; for the remainder of the state, 511 cremations per crematorium for 37 crematoria
- » Hunter, Central Coast and Illawarra crematoria also have cremations per crematorium rates above the state average, reflecting the high rates of cremation is those regions.

#### 4.6.2 Deaths and interment services by Sydney Metropolitan sub-region

For the Metropolitan Sydney sub-regions<sup>35</sup>, points of interest include:

Facilities in each region

- » Sydney West region has the largest no. of cemeteries (22), but lowest no. of burials per cemetery (18), reflecting the historic infrastructure of village cemeteries west of urban Sydney
- » South region has the highest concentration of burials (573 per cemetery; activity is concentrated to two major facilities), followed by West Central region (including Rookwood Cemetery; 477 per cemetery)
- » the major population growth area of South West Sydney is also currently serviced by a historic infrastructure of village cemeteries (10 cemeteries, with 104 burials per cemetery in 2014/15).

Importance to greater Sydney of West-Central region facilities

- » 'strategic' facilities in the West-Central region, including Rookwood <sup>36</sup>, Pinegrove and Castlebrook<sup>37</sup> facilities currently service much of the greater Sydney community
- » as at 2016, the region population is 29.7% of the Sydney Metropolitan population, however 40.3% of greater Sydney total services in 2014/15 were provided by West-Central region facilities, and 54.6% of greater Sydney burials in 2014/15 were at West-Central region cemeteries.

Services within region as % of deaths within region

- » around 4.1% of the interment services in Sydney Metropolitan region are provided to persons who have died outside the region (25,938 burials and cremations, against 24,919 reported deaths for 2014)
- » there appears a significant traffic from across Sydney to the West Central region, which includes the major Rookwood, Castlebrook and Pinegrove cemeteries and crematoria
- » West Central region serviced 10,449 burials and cremations for 2014/15, compared with 5,505 deaths recorded for 2014 (a difference of +4,944 or +89.8%)
- » traffic to the West-Central region appears to overflow most from
  - > Central region (Sydney city, eastern suburbs and inner west, where no facilities with material capacity are available; 2,618 deaths or 58.4% serviced outside the region), and
  - South region (1,210 deaths or 29.6% serviced outside the region), where reasons for seeking service elsewhere may include cemetery capacity constraints, cultural/community and family connections, service types and pricing

» traffic appears least for the North and West subregions (North region provided 19% more services than deaths within the region, and West region serviced 81.5% of deaths within that region).

#### Cremation rates

- » as above; the cremation rate for Sydney (66.3%) is consistent with that for the rest of NSW (66.9%)
- » given proximity constraints in regional NSW, the Sydney cremation rate likely reflects an orientation to burial for many communities in the Sydney population
- » the cremation rate is lowest in West-Central (54.3%), which reflects the incoming traffic to the region for burial services (4,770 burials, 54.6% of greater Sydney burials), rather than low cremation volumes (5,679, the highest of all Sydney sub-regions).

#### Burials per cemetery

- » as above; for Sydney the average is 153 burials per cemetery for 57 active cemeteries
- » the rate of burials per cemetery presents in-principle opportunity to Sydney operators for capture of revenues to fund ongoing maintenance of cemeteries
- » however, the historic village cemeteries of West and South West regions have the lowest rates of burial, and face significant population growth in decades ahead

#### Cremations per crematorium

- » as above, for Sydney the average is 1,434 cremations per crematorium for 12 crematoria; for the remainder of the state, 511 cremations per crematorium for 37 crematoria
- » facilities in the North region are currently the highest volume facilities in NSW providing 2,697 cremations per crematorium for 2 crematoria.

## 4.7 Rate of cemetery land consumption

The following factors are relevant to rates of cemetery land consumption, and considered below:

- » Cremation and burial rates
- » Second interment and 'grave occupancy'
- » Presales
- » Renewable interments
- » Ash interments.

#### 4.7.1 'Snapshot' rate of cemetery land consumption 2014/15

Prior to 2015, the most recent substantive survey of Greater Sydney region cemetery capacity, conducted in 2002-2005, projected exhaustion of available cemetery capacity before 2050. In 2015 CCNSW established a refreshed survey to assess remaining cemetery capacity in the Greater Sydney area (Sydney, Hunter, Central Coast and Illawarra planning regions) as at 1 Jan 2015, as a priority project.

CCNSW is completing analysis and quality assurance work to allow publication of the survey report, later in 2016. The report consolidates information captured from cemetery operators in each region, comprising information in respect of 133 cemetery facilities. CCNSW analysis of responses identifies around 310,000-330,000 grave plots as available in Metropolitan Sydney at 1 Jan 2015; ~120,000 grave plots as available in the Hunter region; ~120,000 grave plots as available in the Illawarra region; and ~23,000 available in the Central Coast region. These figures reflect capacity available for provision by existing operational cemeteries. The figures do not include proposed future cemetery lands, or facilities which have planning approval, but have not commenced operation<sup>38</sup>.

2014/15 burial activity information for these regions can be used to identify a rate of decrease of existing capacity, at the current incidence of deaths and burials per planning region. At 2014/15 burial rates, the rate of decrease of existing capacity in these regions is as follows:

NB that the number of deaths per annum across the more populated regions of NSW Is projected to increase significantly between 2011 and 2056. For Metropolitan Sydney, the number of deaths per annum is projected to increase from 24,330 in 2011 to 37,700 by 2041 (55%)<sup>40</sup>. The CCNSW Greater Sydney cemetery capacity survey report will project future rates of burial and cremation for these planning regions, and potential cemetery capacity exhaustion dates. 2014/15 cemetery activity data provides only a 'snapshot' of the current rate of consumption, which will increase significantly in future years, without changes in interment choices.

#### 4.7.2 Cremation and burial rates

Cremation and burial rates are considered at the regional level, in section 4.4.2 Analysis of 2014/15 metropolitan and regional burial services by sector, above. The 2013 activity data collected for NSW cemeteries and crematoria identified a state-wide cremation rate of 65.3%, which has increased slightly to 66.9% in 2014/15. For Sydney Metropolitan region, the 2013 rate identified was 65.4%, which increased slightly to 66.3% in 2014/15.

While 2013 activity data is not known to contain substantive errors, it was collected to indicate state activity levels, without the process of review and quality assurance of 2014/15 activity information. Differences in rates are therefore viewed with caution, as indicators rather than confirmed trends. In this context, if the changes between 2013 and 2014/15 represent a trend toward cremation, and the cremation rate continues to increase, then that could contribute to reduced pressure on cemetery capacity in future.

However, the relatively low rate for the heavily populated Sydney region, by comparison with adjoining Hunter, Central Coast and Illawarra region rates, suggests a continued orientation to burial for many Sydney communities. The cremation rate for Sydney will be material to cemetery capacity required in future decades. CCNSW intends to publish a Greater Sydney cemetery capacity report later in 2016, including sensitivity testing in respect of the future Sydney cremation rate, and effect upon cemetery land consumption.

It will be of particular interest in 2015/16 whether an ongoing trend toward cremation is in effect, given the effect of the variable to increasing deaths per annum and long term cemetery land requirements.

#### 4.7.3 Second interment and 'grave occupancy'

Rates of second interment and 'grave occupancy' are considered at the regional level, in section 4.4.2 Analysis of 2014/15 metropolitan and regional burial services by sector, above.

2014/15 second interment and 'grave occupancy' figures are detailed below, for NSW, Metropolitan Sydney, rural and regional NSW, and the Hunter, Central Coast and Illawarra subset of regional NSW:

2014/15 activity information in respect of second or subsequent interments carries a caution, in that not all operators systems record in readily reportable form whether a burial is a first or second interment. It is likely that the actual rate is slightly higher than that reported. The rate is highest for metropolitan Crown Trust operators, and in the Hunter and Central Coast regions, where existing facilities face continued and increasing demand, and limited capacity.

The 2013 activity data collected for NSW cemeteries did not differentiate between first and second or subsequent burials, and therefore no trend data is yet available for the rates of second interment and 'grave occupancy'. As referenced above, the substantive survey of Greater Sydney cemetery capacity conducted in 2002-05 considered burial, cremation and grave occupancy as factors relevant to ongoing consumption of new grave plots<sup>42</sup>. While that work did not have industry data on second interments available to inform projection of grave occupancy, the figure used by the survey, referencing discussions with industry, was a grave occupancy rate of 1.4 for Metropolitan Sydney.

If the estimated occupancy rate of 1.4 used in the 2002-05 metropolitan analysis was reasonably accurate, and the current state-wide rate is now 1.4, and the rate in metropolitan areas higher than that, it may be that a trend toward higher grave occupancy is in effect. Similar to cremation rates, the grave occupancy rate in all populous regions, and particularly in Sydney, will be material to cemetery capacity required in future decades. CCNSW intends to publish a Greater Sydney cemetery capacity report later in 2016, including sensitivity testing in respect of the future Sydney cremation rate, and effect upon cemetery land consumption.

#### 4.7.4 Ash interments

Some cemetery facilities are heavily developed for ash interments, consistent with the cremation rate, and with the situation of crematorium facilities within cemeteries. Ash interments may generally be completed at a much higher density than mortal remains interments, and therefore provide a very efficient form of cemetery land use. Nonetheless, arrangements for tracking of cemetery land consumption for ash interment may need to be developed in future, to provide for a reliable forward view to cemetery capacity available for access 'at need' for burials, particularly in metropolitan areas.

#### 4.7.5 Renewable interments

Part 4 of the *Cemeteries and Crematoria Act 2013*, upon commencement, will establish a consistent regime of interment rights for NSW cemeteries, including a regime for renewable interment rights. Implementation of renewable interment rights will be an option available to cemetery operators, which is expected to have the effect of increasing the efficiency of cemetery land usage, by allowing for increased numbers of interments in individual grave plots.

Only 68 renewable interments were reported for 2014/15, from two operators. It is intended that annual activity reporting by cemetery and crematorium operators be continued, to provide for visibility of increased mortality volumes and cemetery and crematorium services in the years ahead as annual mortality volumes are projected to double between 2011 and 2051. Visibility of the takeup of renewable interment rights will also be required to provide for a reliable forward view to cemetery capacity available for access 'at need' for burials, particularly in metropolitan areas.

#### 4.7.6 Presales of burial licences, grave plots and interment rights

Also relevant to cemetery land consumption is the increasing practice of presale of burial licences, grave plots or interment rights. Rights or plots are purchased both in 'at need' and 'pre-sale' scenarios. The volume of grave plots reported as available for new interments at 1 Jan 2015 at the 'Snapshot' 4.7.1 above reflects the no. of plots **not yet used for interments**. The volume of stock available for access in an 'at-need' scenario may be 20-50% less than the volume not yet used, through commitment to a future interment by pre-sale.

Presales have not been included in the parameters of activity reporting for 2014/15, but may need to be considered in future, to provide for a reliable forward view to cemetery capacity available for access 'at need' for burials, particularly in metropolitan areas.

# **4.8 Potential alignments between regional variations and Census information**

CCNSW sought advice from the Department of Planning and Environment Demography Team on considering potential relationships between Census information, most logically religious affiliation and ancestry information, which may have relationships to orientation by communities toward burial or cremation. DPE provided the tables attached at Attachment B and C, detailing the distribution of all people stating a religion in 2011 by planning region, and for those not stating any affiliation, by ancestry by planning region.

There is a logical difficulty in drawing absolute relationships between the profile of a planning region and the burial and cremation activity of that planning region, particularly in Metropolitan Sydney, for reasons which include:

- » limited facilities in some Sydney regions
- » no necessity that person dying in a region is buried or cremated in that region
- » no data differentiating the primary service type for any person buried or cremated outside their region
- » no access to the last addresses of persons buried or cremated, which would allow identification of actual (as opposed to apparent) traffic between regions
- » readiness of access between regions of Sydney, with planning region boundaries not reflecting an effective separation of communities.

Tables provided at Attachments B and C nonetheless provide for Metropolitan Sydney some illustration of community profiles:

- » by religious affiliation; and
- » for those not stating any affiliation, by ancestry.

#### **NSW Religious Affiliation profile Census 2011**

This table provides the distribution of all people stating a religion in 2011, of which there were 5.1 million, by NSW planning region. The data does identify concentrations above the state-wide average for some communities understood to maintain an orientation toward burial, in the following regions:

Metropolitan Sydney - Central region (Orthodox, Islam, Judaism)

Metropolitan Sydney - South region (Orthodox, Islam)

Metropolitan Sydney - South West region (Orthodox, Islam)

Metropolitan Sydney - West Central region (Orthodox, Islam).

These concentrations may contribute to the Metropolitan Sydney cremation rate remaining very close to the state-wide average, where the absence of proximity constraints for cremation services in Sydney would otherwise mitigate toward a rate higher than the state-wide average

#### **NSW Ancestry Profile Census 2011**

This table provides the distribution of all people who said in the Census they had 'No Religion', or didn't state a Religion. There were 1.4 million people choosing this category. In this table the differentiation is by the stated Ancestry of the person, which has potential for association with cremation / burial choices.

In this dataset it may be of note that

- » 'No Religion' Ancestry is largely comprised of people with an Oceanian or North-West European Ancestry, and in the absence of other guidance, this group may broadly follow the same break down of choice as the population in general (i.e. Catholic or Anglican split).
- » North-East Asian Ancestry is the third largest group, understood to comprise largely mainland Chinese population, who have a very young population profile, and it may reasonable to anticipate that, amongst this group, cultural preferences are changing, and cremations may be rising amongst this group.

It may be of benefit in future that qualitative research work proceeds among key communities, as a complement to the quantitative census information, to allow more confident determination of community preferences, and reasonably foreseeable interment choice trends.

# 5. Findings

Analysis of the tables provided in the body of the document delivers the following principal findings:

### No. of deaths v No. of interment services

- » Whole of NSW a net incoming traffic to NSW for burial and cremation services (53,945 burials and cremations in 2014/15, compared with 52,320 deaths recorded for 2014, a difference of +1,625 or +3.1%)<sup>43</sup>
- » Deaths: estimated populations of metropolitan and regional NSW as at 2014 were Metro 4,509,579 (60%), and rural and regional 3,008,893 (40%); deaths recorded for 2014 were Sydney 24,919 (47.7%) and regions 27,243 (52.3%), reflecting the difference in age profiles between Sydney and regional communities
- » Metropolitan Sydney a net incoming traffic to Metropolitan Sydney for burial services (25,938 burials and cremations for 2014/15, compared with 24,919 deaths for 2014, a difference of 1,019 or 4.1%)
- » NSW excluding Sydney a net incoming traffic to regional NSW for services (28,007 burials and cremations for 2014/15, compared with 27,401 deaths for 2014, a difference of 606 or 2.2%)

## Distribution of services by sector

- » Private sector operators provide the majority (55.7%) of primary services in NSW, delivering 30,049 primary services, comprising 2,845 burials and 27,204 cremations
- » Private sector operators provide 75% of cremation services in NSW, including 69% of metropolitan area cremations (11,821), and 81% of regional cremations (15,383)
- Councils provide 22.7% of overall services; the largest share of all burials in NSW (8,736, or 49% of NSW burials), and the great majority of regional burial services (7,840, or 86% of regional burials)
- » Crown Trusts provide 21.3% of primary services in NSW, but provide the great majority of metropolitan burial services (5,984, or 69% of metropolitan burials)

43 While the reporting period for deaths (2014) and services provided (2014/15) are not consistent, the no. of services provided is sufficiently higher than the no. of deaths which may be expected to be recorded in NSW for 2014/15 as to confirm a rate of traffic incoming to NSW for burial and cremation services.

## **Cremation rates**

- » the Sydney cremation rate (66.3%) is consistent with the rest of NSW (66.9%); given proximity constraints in the regions, the rate likely reflects an orientation to burial for many communities in greater Sydney
- » a much higher level of cremation is current in the Central Coast, Hunter and Illawarra regions (78.8%)
- » the number of cremations for 2014/15 is considerably higher than 2013 (+2,288) and suggests an increase in the state-wide cremation rate of 1.4% from 65.3% to 66.9%
- » it will be of particular interest in 2015/16 whether an ongoing trend toward cremation is in effect.

## **Burials per cemetery**

» there is great variance in burial rates per cemetery between metropolitan and regional areas; for Sydney the average is 153 burials per cemetery for 57 active cemeteries; for the remainder of the state excluding Sydney, 11 burials per cemetery for 794 active cemeteries.

## Second interments and occupancy rates

- » in the metropolitan area, where cemetery space is at a premium, the rate of second or subsequent interment is 30.3% of all burials, suggesting a 'current' grave occupancy rate of 1.45.
- » the figures identify that metropolitan cemetery space is being consumed with relative efficiency, and the occupancy rate is expected to increase in future years.

## Rate of cemetery land consumption in Metropolitan Sydney

- » CCNSW calculates that as at 1 Jan 2015 there were around 310,000-330,000 grave plots available for new interments in Metropolitan Sydney
- » there were 6,013 interments in new graves in Sydney in 2014/15, with around 2% of available stock consumed for interments; steep increases in deaths per annum in future years will greatly increase the rate.

## Importance to greater Sydney of West-Central region facilities

- » 'strategic' facilities in the West-Central region of Sydney, including Rookwood, Pinegrove and Castlebrook facilities currently service much of the greater Sydney community
- » the region sustains 29.7% of the metropolitan population, but provides 40.3% of primary services (burials and cremations) and 54.6% of greater Sydney burials.

## Interment and memorialisation following cremation

- » 2013 activity data identified the interment of 30,498 remains in NSW cemeteries (17,968 burials and 12,530 ash interments), 60.7% of deaths recorded in NSW for the period
- » 2014/15 data identifies the disposition of 29,951 remains in NSW cemeteries (17,853 burials and 11,738 ash interments or scatterings), 57.4% of deaths recorded in NSW for the period
- » the Metropolitan Sydney 'share' of reduced ash interments (approx. 80% of the reduced total) is much higher than the metropolitan 'share' of ~50% of total services provided
- » regional Councils report a rate of ash interment or ash scattering to 80.5% of cremation services provided (however the rate of ash interment will include interment of ashes cremated by other operators).

## Follow-up work which can be expected to be of value in future

Given the findings and indications brought forward by the 2014/15 activity survey, the following work streams are proposed for consideration:

- » continued annual activity reporting by cemetery and crematorium operators, to provide visibility of increased mortality volumes and efficiency of cemetery land use in the years ahead, as annual mortality volumes double between 2011 and 2051. Activity reporting can provide an evidence base of actual rates of cremation, mortal remains interment, and second and subsequent interments, to inform planning for future community infrastructure requirements.
- » discussion with cemetery and crematorium operators of the apparent decline in ash interment and memorialisation following cremation; to determine whether the trend is perceived or actual; and what actions may reasonably be contemplated to seek to increase rates of ash disposition and memorialisation.
- » completion and publication of the CCNSW Greater Sydney cemetery capacity survey report, that work reconciling burial and cremation activity against estimated remaining cemetery capacity as at 1 January 2015, and projecting future rates of burial, cremation and cemetery land consumption.
- » follow-up work on tracking of cemetery land use for ash interment; in some cemeteries large areas have been developed for intensive ash interments; and upon commencement of Part 4 of the *Cemeteries and Crematoria Act 2013* a prohibition on disturbance of ash interments will become effective. Given the focus on providing sufficient cemetery land for forecast future interments, further work with cemetery operators is proposed, to determine whether an efficient approach to reporting the commitment of cemetery land to ash interment may be adopted.






