Planning Proposal (PP_2014_PARKE_002_00) – rezone land at Newell Highway, Saleyards Road & Ackroyd St, Parkes to Zone IN1 General Industrial

I refer to your letter of 16 July 2014 requesting a Gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* (EP&A Act) to rezone land at Newell Highway, Saleyards Road and Ackroyd Street, Parkes from Zone RU1 Primary Production to Zone IN1 General Industrial in the *Parkes Local Environmental Plan 2012* (LEP).

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to conditions in the attached Gateway determination.

The Minister delegated plan making powers to Councils in October 2012. It is noted that Council has accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue authorisation for Council to exercise delegation to make this plan (Attachment 1).

The amended LEP is to be finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office (parliamentary.counsel@pco.nsw.gov.au) 6 weeks prior to the projected publication date. A copy of the request should be forwarded to Planning and Environment (planmaking.monitoring@planning.nsw.gov.au) for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 57(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

In accordance with "A Guide for the preparation of local environmental plans" attachment 5 – Delegated plan making reporting template (Attachment 2) is enclosed for Council's information. Table 2 of the attachment is to be completed and included in Council's section 59 submission.

Gateway Determination

Planning proposal (Agency Ref: PP_2014_PARKE_002_00) to rezone land within the boundaries of Newell Highway, Saleyards Road and Ackroyd Street, Parkes, being Lot 549 DP657444, Lot 632 DP750179, Lot 7023 DP1054934, Part Lot 7022 DP1054934, Part Lot 101 DP1169531 and Lot 19 DP1047309 from Zone RU1 Primary Production to Zone IN1 General Industrial and also amend the minimum lot size from 400 hectares to 1500m2.

I, the General Manager, Western Region Team at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning & Assessment Act* 1979 (EP&A Act) that an amendment to the Parkes Local Environmental Plan (LEP) 2012 to rezone land from Zone RU1 Primary Production to Zone IN1 General Industrial and amend the minimum lot size from 400 hectares to 1500m2 should proceed subject to the following conditions:

- 1. Community consultation is required under sections 56(2)(c) and 57 of the EP&A Act as follows:
 - (a) the planning proposal is classified as low impact as described in *A Guide to Preparing LEPs (Planning & Infrastructure 2013)* and must be made publicly available for a minimum of **14 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Planning & Infrastructure 2013)*.
- 2. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act:
 - Transport for NSW Roads and Maritime Services
 - John Holland as manager of railway land on behalf of Transport for NSW
 - Office of Environment and Heritage
- 3. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 4. Prior to submitting the planning proposal under Section 59 of the EP&A Act the LEP maps are to be compliant with the Department's Standard technical requirements for LEP maps.
- 5. The timeframe for completing the LEP is to be **9 months** from the week following the date of the Gateway determination.
