Planning Proposal (PP_2014_PARKE_003_00) – housekeeping amendments

I refer to your letter of 22 July 2014 requesting a Gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* (EP&A Act) to amend the *Parkes Local Environmental Plan 2012* (LEP) by:

- Including the land use term of 'hospital' in a Zone SP2 Road Infrastructure Facilities located between the Broken Hill Railway Line and the Newell Highway, generally through Medlyn Street Parkes
- Including the permissibility of 'caravan park' and 'market' in Zone RE1 Public Recreation
- Including the permissibility of 'water storage facility' in Zone RU1 Primary Production
- Correcting an omission to the Lot Size Map and Land Zone Map by rezoning land from Zone R5 Large Lot Residential to Zone R1 General Residential at some properties along Molong Road, Parkes
- Amending wording and minor type error of Clause 4.2A Erection of dwelling houses, dual occupancies (attached) and secondary dwellings.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to conditions in the attached Gateway determination.

The Minister delegated plan making powers to Councils in October 2012. It is noted that Council has accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue authorisation for Council to exercise delegation to make this plan (**Attachment 1**).

The amended LEP is to be finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office (parliamentary.counsel@pco.nsw.gov.au) 6 weeks prior to the projected publication

date. A copy of the request should be forwarded to Planning and Environment (planmaking.monitoring@planning.nsw.gov.au) for administrative purposes.

The amended LEP maps and GIS data is to be uploaded to the Department's FTP site at ftp://lepup:lep_upload@203.3.194.247/ and the map information emailed to pcgis@planning.nsw.gov.au and a copy to planmaking.monitoring@planning.nsw.gov.au and westernregion@planning.nsw.gov.au

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 57(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

In accordance with "A Guide for the preparation of local environmental plans" attachment 5 - Delegated plan making reporting template (Attachment 2) is enclosed for Council's information. Table 2 of the attachment is to be completed and included in Council's section 59 submission.

Gateway Determination

Planning proposal (Agency Ref: PP_2014_PARKE_003_00) to amend the Parkes Local Environmental Plan 2012 by: including the land use term of 'hospital' in a Zone SP2 Road Infrastructure Facilities located between the Broken Hill Railway Line and the Newell Highway, generally through Medlyn Street Parkes; including the permissibility of 'caravan park' and 'market' in the Zone RE1 Public Recreation and 'water storage facility' in Zone RU1 Primary Production; correcting an omission to the Lot Size Map and Land Zone Map by rezoning land from Zone R5 Large Lot Residential to Zone R1 General Residential Molong Road Parkes; and amending minor typing and wording in Clause 4.2A Erection of dwelling houses, dual occupancies (attached) and secondary dwellings.

I, the General Manager, Western Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the Environmental Planning & Assessment Act 1979 (EP&A Act) that an amendment to the Parkes Local Environmental Plan (LEP) 2012 to resolve anomalies, improve wording in clauses and to increase permissibility in zones, should proceed subject to the following conditions:

- Community consultation is required under sections 56(2)(c) and 57 of the EP&A Act as 1. follows:
 - the planning proposal is classified as low impact as described in A Guide to (a) Preparing LEPs (Planning & Infrastructure 2013) and must be made publicly available for a minimum of 14 days; and
 - the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Planning & Infrastructure 2013).

No consultation is required with public authorities under section 56(2)(d) of the EP&A Act.

- A public hearing is not required to be held into the matter by any person or body under 2. section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- Prior to submitting the planning proposal under Section 59 of the EP&A Act the LEP maps 3. are to be compliant with the Department's Standard technical requirements for LEP maps.
- The timeframe for completing the LEP is to be 9 months from the week following the date 4. of the Gateway determination.
