Planning Proposal PP10/0005 - Tweed Local Environmental Plan 2014 Amendment No 13 - Lot 1 DP 1046935 Old Lismore Road, Murwillumbah (Subject Site) and Review of the Hundred Hills **Release Area (Housekeeping Review)** 

Tweed Shire Council resolved at the Planning Committee of 9 April 2015 to commence the process of amending the Tweed Local Environmental Plan 2014 (LEP 2014) by rezoning the subject site Lot 1 DP 1046935, Old Lismore Road Murwillumbah from the current R5 Large Lot Residential zone to R2 Low Density Residential. In addition, Council resolved to undertake LEP 2014 amendments to the wider Hundred Hills Release Area, known as the Housekeeping Review to reflect the established low density residential character of the locality.

Tweed Shire Council now requests this planning proposal be referred to the LEP Review Panel for a Gateway Determination in accordance with section 56 of the Environmental Planning and Assessment Act 1979 (EP&A Act).

In order to confirm the suitability of the planning proposal the following studies have been prepared to accompany public exhibition of the proposal, subject to the gateway determination:

- 1. Traffic extension to Castlefield Drive
- 2. Geotechnical, Engineering and Stormwater assessment
- 3. Flora and Fauna Assessment
- 4. Aboriginal Cultural Heritage Due Diligence
- Contaminated Land Preliminary Study 5.

The following timeframe is envisaged for the completion of the planning proposal. It is anticipated the planning proposal will be able to be completed within a 10-12 month timeframe as outlined in the following table.
