## Planning Proposal No PP\_2014\_TWEED\_007\_00 – Gateway Determination alteration/extension

I refer to your letters of 18 June and 8 July 2015 in relation to an alteration to Planning Proposal No. PP\_2014\_TWEED\_007\_00, relating to land at Bilambil Heights, and a request to extend the timeframe for finalisation of the Local Environmental Plan (LEP).

I have determined as the delegate of the Minister, in accordance with section 56(7) of the *Environmental Planning and Assessment Act* 1979 to alter the Gateway Determination dated 1 October 2014 for PP\_2014\_TWEED\_007\_00. The Alteration of the Gateway Determination is enclosed.

In doing so, I have agreed to the inclusion of the subject land at Lot 30 DP 850230, 61 Marana Street, Bilambil Heights on the Key Sites Map for the purposes of clause 7.13. *Development requiring the preparation of a DCP* of Tweed LEP 2014.

Further, I have also agreed to the extension of time to complete the LEP by three (3) months. The LEP is now due for finalisation by 8 October 2015.

## Alteration of Gateway Determination

## Planning proposal (Department Ref: PP\_2014\_TWEED\_007\_00)

I, the Acting General Manager, Northern Region, at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* to alter the Gateway determination dated 1 October 2014 for the proposed amendment to the Tweed Local Environmental Plan 2014 as follows:

- 1. Change the description of the Planning Proposal:
  - from "to rezone Lot 30 DP 850230, Bilambil Heights for residential development"
  - to "to rezone Lot 30 DP 850230, Bilambil Heights for residential development and to include the subject land on the Key Sites Map for the purposes of Clause 7.13"
- 2. Delete condition 4:

"4. The timeframe for completing the LEP is to be 9 months from the week following the date of the Gateway determination"

and replace with a new condition 4:

"4. The LEP is to be completed by 8 October 2015."
