Proposal Summary :	Amend the Bathurst Regional Local Environmental Plan 2014 to include provisions which permit the temporary use of land (except for land within zone RU2 Rural Landscape), subdivision of lots zoned both rural and residential where land zoned rural is below the minimum lot size and to ensure development in drinking water catchments considers the likely impacts on the catchment.

e) List any other matters that need to be considered : 1.2 Rural Zones: The Ministerial Direction is relevant as the proposal affects land within existing rural zones. The Direction requires a planning proposal must not rezone land from a rural zone to a residential zone or contain provisions that will increase the permissible density of land within a rural zone. The planning proposal is consistent with this Direction as it does not propose to amend the land use zone or permit an increase density of residential development but provides clarity and flexibility.

1.5 Rural Lands: The Ministerial Direction is relevant as the planning proposal effects land within a rural zone. The Direction required the planning proposal to be consistent with the rural planning principles and rural subdivision principles in the SEPP (Rural Lands) 2008.

The planning proposal is consistent with this Direction and supports productive sustainable economic activities by providing a mechanism which permits subdivision of certain lots which contain land in both a rural and residential zone and clarifies where dwellings are permitted. The proposal does not permit an increase in the number of dwellings permitted on rural land or the creation of additional allotments below the minimum lot size. It will not result in the fragmentation of rural land and does not impact on services and infrastructure. The model clause allows subdivision of land zoned for residential purposes while maintaining the existing provisions for rural land.

2.1 Environmental Protection Zones: The Ministerial Direction is relevant as the planning proposal affects land within environmental protection zones. The Direction requires that a planning proposal must not reduce the environmental protection standards that apply to land. the planning proposal is consistent with the Direction and provides that development will result in the continued protection and long term maintenance within environmental protection zones.

4.3 Flood Prone Land: The Ministerial Direction is relevant as the proposal will apply across the Bathurst LGA. The proposal is consistent with this Direction as it does not undermine the existing flood prone land provisions.

4.4 Planning for Bushfire Protection: The Ministerial Direction is relevant as the proposal will apply across the Bathurst LGA. The proposal is consistent with this Direction as it does not undermine the existing bushfire prone land provisions.

SEPP (Rural Lands) 2008: The SEPP is relevant as the planning proposal affects rural land. The planning proposal is consistent with the rural planning and rural subdivision principles of the SEPP.

Comment :	The planning proposal seeks to include provisions that will apply to land as follows:
	- Temporary use of land: All land except for land within zone RU2 Rural Landscape
	- Minimum lot sizes for certain split zone lots: Land within a rural, environmental protection, residential, business or industrial zone.
	- Drinking water catchment: All land identified on the Drinking Water Catchment Maps (prepared as part of this planning proposal).

Adequate draft maps (DWC_006, DWC_007, DWC_001, DWC_012, DWC_013, DWC_015 and DWC_0016) are included in the planning proposal. These maps will need to comply with the technical mapping guidelines at section 59.

	2. Consultation is required with the NSW Office of Water under Section 56 (2)(d) of the EP&A Act. The NSW Office of Water is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the planning proposal prior to community consultation.
	3. Consultation is required with Oberon Council and City of Lithgow Council. The local governments are to be provided with a copy of the planning proposal and any relevant supporting material.
	4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
	5. Prior to submission of the planning proposal under section 59 of the EP&A Act the relevant LEP Maps that apply to water catchment are to be prepared compliant with the Department's 'Standard technical requirements for LEP maps'.
	6. The timeframe for completing the LEP is to be 9 months from the week following the date of the Gateway determination.
	7. Bathurst Regional Council be authorised to exercise plan making delegations.
