

Alteration of Gateway Determination

Planning Proposal (Department Ref: PP_2015_BYRON_003_00)

I, the Executive Director, Regions at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 31 August 2015 (as since altered) for the proposed amendment to the Byron Local Environmental Plan 2014 as follows:

1. Delete paragraph 2:

"I, the Acting Executive Director, Regions at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the *Byron Local Environmental Plan (LEP) 2014* to define short term rental accommodation, require development consent for short term rental accommodation and schedule certain forms of short term rental accommodation as exempt development, should proceed subject to the following conditions:"

and replace with a new paragraph 2:

"I, the Executive Director, Regions at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the *Byron Local Environmental Plan (LEP) 2014* to define short-term rental accommodation, require development consent for short-term rental accommodation and schedule certain forms of short-term rental accommodation as exempt development, should not proceed."

2. Delete conditions 1 to 5.

Planning Proposal PP_2015_BYRON_003_00 – Alteration of Gateway Determination – Discontinuation of Planning Proposal
