	owners of the original "Temora Run" and the site in 1862 of the "Battle of the Bland", the shoot-out between Sir Frederick Pottinger and Gardiner's bushranger gang following the Eugowra Gold Robbery.			
	The "Battle of the Bland". At this site on 8th July, 1862, the "Battle of the Bland" took place between Gardiner's bushranger gang and the law; Police Inspector Sir Frederick Pottinger, Det. Patrick Lyons and Richard Mitchell, Clerk of Petty Sessions, Condoblin. The battle followed the capture on the previous day of bushrangers Johnny Gilbert, Charlie Gilbert and Henry Manns near Mrs Hardy's "Ariah" station homestead at Beckom. The bushrangers were returning from the border area along the Great Western Stock Route after trying to cash gold stolen in the Eugowra Rocks gold robbery. At that time this was the largest gold robbery in Australia's history. Johnny Gilbert avoided capture and rode over 70 miles in 10 hours to alert members of the Gardiner gang hiding in the Weddin Ranges. Pottinger, Lyons, Mitchell, the two prisoners and a pack horse carrying the gold, overnighted at "Quandary" homestead with George Harmon. The next morning as they approached Mrs Sproule's homestead, they ran into an ambush. In the shoot-out, which lasted between ten and fifteen minutes, Lyons was thrown from his wounded horse, the prisoners escaped, and Pottinger retreated 12 miles westward to "Quandary" for more ammunition and assistance. On his return he found Lyons unharmed, but the bushrangers had fled. Pottinger had captured 213 oz. of gold, which with the help of an armed guard, he returned to Forbes, arriving to a hero's welcome on 14th July, 1862. (Text on history panel at the site). The site, situated on part of the Great Western Stock Route, beside the Wolladilly Creek and the home of Mrs			
	Frances Sproule, was also a part of the western access route for the earlier Aboriginal people who would have followed the water course. They would have accessed this near its eastern end where it became a tributry to the Trigalong and Narraburra Creeks, feeding to the Lake Cowal area. Following it westwards, they would have come to its source near the current (2006) Temora- Barmedman Road. Continuing over the road site, they would then have picked up the source of the Mirrool Creek close by, and been able to follow it into the western country. They could also have followed the same course eastwards from the west. As the flow of both creeks is intermittent, they could only have done this in good seasons when water was available, particularly in the Mirrool, however, at this site, the "lagoon" was one of the best waterholes along this route, being around 20 ft. deep, and the water almost permanent.

The area will be sufficient to allow full access without impeding progress by stock when required. Additional works to include - Clearance of windfall tree debris from the watercourse to suitable locations beneath the significant trees; - Minor reinforcement and stabilisation of the creek banks, using stakes, brush and creekbed silt, which have been damaged and eroded by stock access; - Revegetation of the three major local species in the vicinity of the main tree groupings and natural surface drainage lines.
