FIRST HEADING

1. Temora Shire Council, together with our community, continue to be in shock over the horrific Bushfires, particularly in the Snowy Valleys Local Government Area (Tumut and Tumbarumba Districts), and, to a lesser extent, the Greater Hume Shire (GHS). Everyone feels sickened and a strong desire to help those, particularly those who have lost their homes. We also feel a tremendous debt owed to those brave souls who have and continue to fight these wretched bushfires. Council places on record our warm appreciation to all our Temora Shire Emergency Servicemen and women who have given time to assist others, especially our friends in the Snowy Valleys/Greater Hume Region. Their selflessness and bravery is most inspiring. We place on record our deepest sympathy to those who have lost their loved ones. May they know they shall not be forgotten.
Temora Shire Council has been on the 'front foot' and offered genuine and real support, wherever we can. We recently launched the register for those Shire residents who wished to open their homes to those who have lost everything. This has been received very well with over 60 beds being available, together with our Recreation Centre, which Council also offered. Last week, Council launched the Mayor's Bush Fire Appeal, with already \$5,000 donated. In speaking regularly with Mayor of Snowy Valleys, Cr James Hayes OAM, he informs us 'cash' is what is needed most, now, for those who have lost everything. The Appeal will formally close on 31st January. Mayor Hayes has advised they have a Foundation set up, which our Funds will be deposited into, ensuring every dollar will go to those families who need it most. I know every Citizen in Temora Shire has donated and will donate whatever their circumstances so dictate. Please know, it is very much appreciated by us all. The Prayers and thoughts of us all remain with Mayor Hayes, Greater Hume Shire Mayor, Cr Heather Wilton, their Councillors, their staff and their communities. Temora Shire are here for them, whenever they need to reach out.
2. The Year 2020, the beginning of a new decade, will be an exciting, busy & productive one. Council has countless projects underway and scheduled, many of which include the State Government's Stronger Country Communities and the Federal Government's \$2 Million Drought Support Extension Programme. Our staff will also implement the remainder of our \$13.1 Million 2019/20 Capital works programs. Once again, I ask our Shire community for their patience and understanding, as our team work through this very busy and exciting year ahead.
3. As Council are aware, the General Manager and I have been lobbying consistently, on Council's behalf, to have the Terminal Area Forecast (TAF) Service reinstated at Temora Aerodrome. Our Federal Member for Riverina, the Hon Michael McCormack MP has been most helpful in facilitating meetings with both he and the Minister responsible, the Hon

Susan Ley MP. We have been advised by Mr McCormack that a Draft report will soon be made available for public comment. Mr McCormack has also encouraged us to obtain as many letters of support from interested and impacted groups who see value in ensuring Temora Aerodrome has our TAF Service reinstated. Mr McCormack did indicate he would again meet with us during the consultation period, which will be 'soon'. For many and varied reasons, it is crucial we have a TAF Service again, and I recommend to Council that we continue intense lobbying for the re-instatement of our TAF Service.

RECOMMENDATION: That Council continues intense lobbying of the Federal Government for the essential re-instatement of the TAF Service at Temora Aerodrome.

4. 2020 is also a Council Election Year. Every four years in New South Wales, ratepayers in our 128 local government areas go to the Polls, on the second Saturday in September. This year, Temora Shire will elect nine Councillors on Saturday 12th September. I ask every citizen who has a genuine commitment to enhancing Temora Shire, who's willing to work hard and be part of a strong and united team – to please consider standing for election. Any Councillor and I are more than happy to discuss our role with any potential candidate.

Council's Engineering Department have identified the need to conduct a partial road closure/opening of Cassidy's Road to address an alignment issue. As it currently stands, the middle section of Cassidy's Road is constructed outside of the dedicated road reserve. Currently, the constructed road cuts across private property (see attached linen plans).

Background:

In mid-2017, Council endorsed to proceed with the closure/sale of the northern section of Cassidy's Road, and to transfer the remainder from a Crown to a Council Road. Subsequently, Crown Lands rejected this proposal as it would remove legal access to Lot 84 DP 750859 (located on the corner of Cedar Road and Cassidy's Road). Cedar Road does provide access to this lot however it is a declared travel stock route (TSR) and TSRs are not considered to provide legal access.

Following this, the transfer of the road (in its entirety) from Crown to Council was gazetted in December 2017.

Legislation was amended in late 2018, which overrides any outstanding applications. As a result of this a new road closure/opening application must be submitted under the new law.

Linen plans have already been developed and sent for registration, however without Crown Land endorsement, registration of the plans cannot proceed.

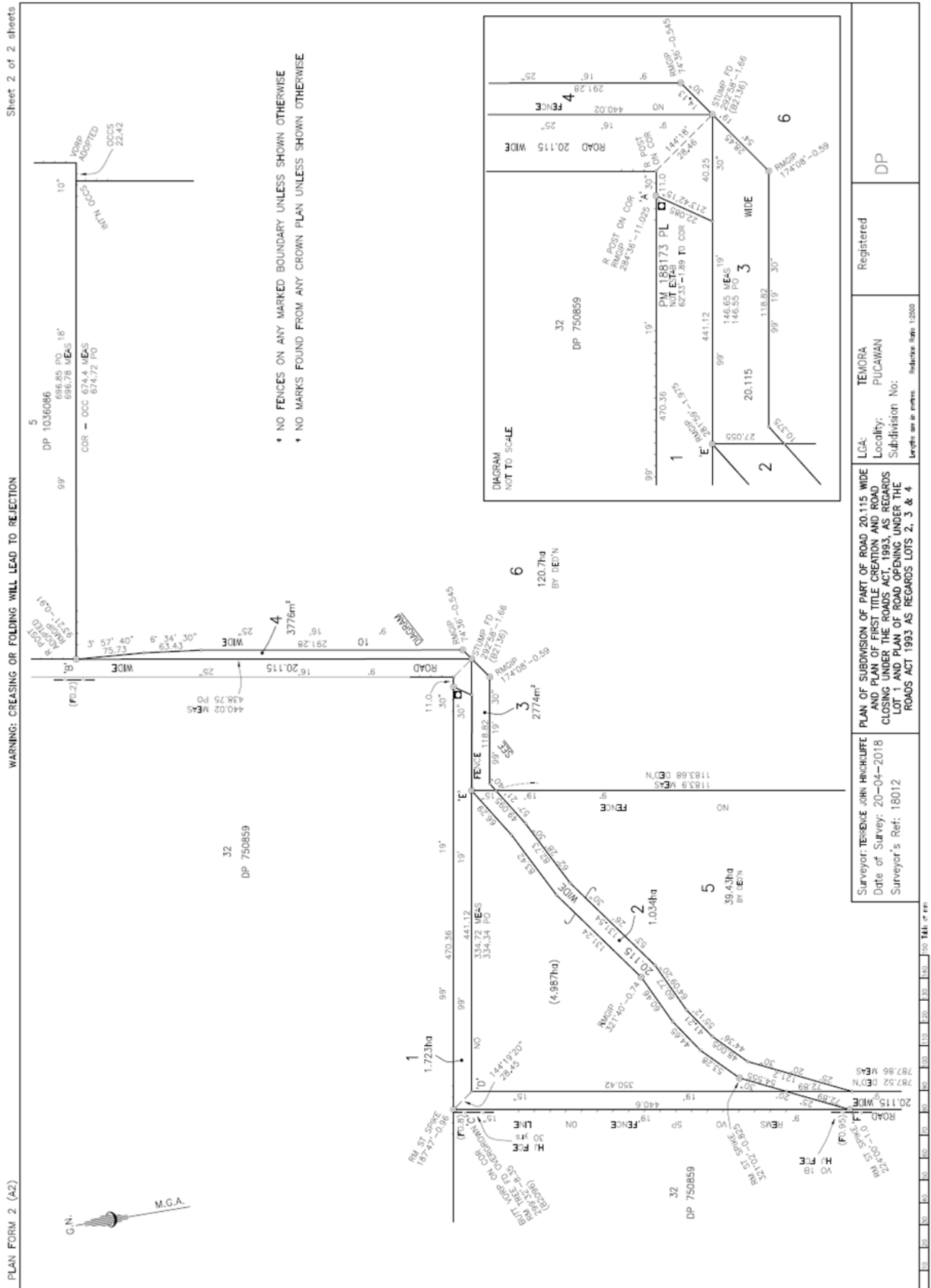
Process to Proceed:

The application process for the road closure/opening requires Council approval, and will detail the closure of the section marked 1 on the attached linen plan, and the opening of sections marked 2, 3 and 4. This will also involve notification to adjoining landholders via newspaper advertisement and written correspondence, as well as notification to the required authorities.

REPORT

Council has recently published an article via Facebook and in the January Narraburra News edition as attached. This article was initially developed by Councils LEMO in context to accessing properties in an emergency however due to being related to rural addressing input was sought from the Manager of Administration and Finance and Councils Rates Officer.

This allowed the article to include further information on what is acceptable as a rural address and what isn't in compliance to the Australian & New Zealand Rural and Urban Addressing Standards (AS4819) and the NSW addressing Policy.

Currently Council in the standard fees and charges has the following fees associated to Rural Addressing. (All prices below are GST inclusive)

Create, Supply and Measure (Not on new Subdivision) = \$80

Backing Plate each = \$2.50

Numbers each = \$3.00

These fees were introduced in 2019 to aid in cost recovery for addressing in consistency with other Councils that already had fees implemented. To date these fees have not had to be charged on any addressing.

In relation to the article published requesting residents to ensure they have the correct addressing for the purpose of being located by emergency services, while also noting the ongoing dry conditions facing rural residents of Temora Shire it's requested that the fees for Rural Addressing be waived for a period up to the 30th of June 2020. This is to encourage residents to request their addressing to be updated during this period.

ARITCLE – Published via Council Social Media and Narraburra News

In the light of the recent bushfires, Temora Shire Council would like to remind ratepayers of the importance of accurate rural addressing and visible rural address numbers on entrance to properties.

In an emergency, having the correct number displayed on your gate and having an incorrect, or no number showing, could be the difference between life and death.

Rural addressing provides a standardised means of locating rural properties throughout Australia with a system that is accurate, easy to understand, and easy to apply. Addresses in rural and semi-rural areas are determined by a distance based numbering system.

Council has the role of allocating property addresses and ensuring addresses comply with the relevant standards and policies. A central addressing database is used by government departments, emergency services and businesses to validate property addresses. Australia Post also require a correct rural address – RMB, RSS, lot numbers and property names are no longer accepted (property name may still be included in addition to the rural address).

The rural address assigned to your property is listed on your rates notice.

Please contact Council's rates department on 6980 1100 (option 3) if you have any queries regarding your property address or would like to update your postal address.

If you do not have a rural address number which can be clearly seen from the road, or if these are illegible, please contact Council's engineering department on 6980 1100 (option 1).



12 ENVIRONMENTAL SERVICES**12.1 UNDERGROUND PETROLEUM STORAGE SYSTEMS CHANGES TO MANAGEMENT**

REPORT

As of 1st September, 2019, NSW Councils have re-assumed responsibility for regulating most underground petroleum storage systems (UPSS) in their respective local government area. The Environmental Planning Association (EPA) will remain the regulator for sites that hold an EPA licence, are operated by a public authority, are in unincorporated areas of the state or are subject to a regulatory notice issued by the EPA.

Council Officers have been receiving ongoing training in regards to this new responsibility from the EPA and have been advised that during this transition ongoing support will be offered.

Additionally, Council Officers are working on databases and incorporating site inspection checklists within the Council systems. During this process it is proposed to furnish information to the owners/proprietors of known sites within the local government area that have underground petroleum storage systems, to better educate on this regulated process.

As this process requires compliance inspections it is proposed to introduce a new fees and charges for this ongoing responsibility for the 2020/2021 financial year.

The fee proposed is in line with many of Councils existing statutory regulatory processes. Therefore, the fee per annual inspection will be incurred at \$200 per site.

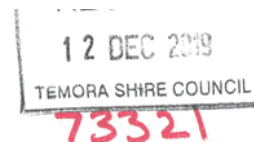

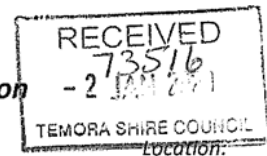

I am writing to you today to seek funding for a new pilot program, *Ready for Life*, to be presented to students in the Support Unit at Temora High School in 2020. The program aims to assist students in gaining the skills required to participate successfully and positively in the community by using community based instruction. The concept of community based instruction is targeted towards the acquisition and improvement of life skills being taught in the classroom, and furthermore accessing facilities in the community.

Community based instruction provides students with disabilities the opportunity to interact with people who do not have disabilities. It also provides them with the opportunity to acquire skills in a range of settings. Students will undertake a variety of activities within the community to develop their communication, pre-vocational, budgeting, independent living and leisure skills. These community partnerships will benefit the students and wider community through relationship building, skills acquired and building a more tolerant and inclusive society. Currently, our students volunteer for the Meals on Wheels program and have shown significant growth in their social skills and work ethic. Due to this success, we are looking to expand these opportunities through the program to incorporate a variety of different local businesses and organisations. We are seeking to collaborate with Temora Men's Shed, Saint Vincent De Paul, Salvation Army, Temora District Hospital, Temora Show Society, Green Stone Lodge, Naraburra Lodge and Temora Council's Pound and Temora Town Hall Theatre to immerse our students in a range of settings to build skills and give back to our local community.

This program has the potential to improve the lives of not only our students, but the wider community members of Temora. It will seek to build new and strengthen existing community partnerships to enhance the lives of students with disabilities. I look forward to discussing the *Ready for Life* program in further detail with you.

Thank you for your correspondence of 22 November 2019 on behalf of the General Manager of Temora Shire Council, Mr Gary Lavelle, regarding the NSW Electoral Commission's (NSWEC) cost estimate for conducting the Council's upcoming election.

I would like to acknowledge the Council's concerns about the quote it received from the NSWEC for conducting its election in September 2020.

The costs of councils' elections conducted by the NSWEC in September 2020 were always going to increase compared to previous elections. As noted by the Independent Pricing and Regulatory Tribunal (IPART), the key driver of this increased cost is the NSWEC's greater focus on managing risk in relation to project management, security and the health and safety of election workers.

The Government is addressing this increase in councils' election costs by contributing close to \$20m to fund the NSWEC's corporate overheads in relation to the 2020 local government elections, thereby ensuring these costs are not passed onto councils. This contribution has ensured that the increase in councils' election costs for the 2020 elections is less than it would have been if this contribution had not been made.

Under the approved funding model, councils are responsible for meeting both the direct and indirect costs of their elections.

It is matter for the NSWEC to determine what level of service is required to undertake councils' elections in a manner that ensures their integrity, that delivers timely election results and ensures the health and safety of the NSWEC's employees and others attending polling places.

If councils are unhappy with the quote the NSWEC has provided to them, the Government would encourage them to discuss this directly with the NSWEC with a view to identifying opportunities to reduce the foreshadowed election costs or to explore options for engaging an alternative electoral services provider.

The Government is committed to further reducing councils' election costs and, as indicated in its response to IPART's final report, it will be consulting with the sector early next year on extending to all councils the option of conducting their elections by universal postal voting instead of attendance voting from the 2024 elections.
