6. That a public hearing on the reclassification of the subject land in accordance with section 29 of the Local Government Act 1993 and section 57 of the Environmental Planning and Assessment Act 1979 be held after completion of the public exhibition

period;

7. That an authorisation to exercise delegation be issued to Council; and

8. That a revised project time line (that addresses the additional steps to be completed by Council due to an authorisation to exercise delegation being issued) be included in the

Planning Proposal prior to public exhibition.

Supporting Reasons:

The proposal seeks to reclassify the Kolora Aged Care Facility, Lochaber Crescent, Guyra, from community to operational land. The purpose of the reclassification is to permit the sale of the site to help fund the construction of a new replacement aged care facility in Guyra. The Planning Proposal is needed as it is the only avenue available to Council to reclassify the land from communiy to operational status. The subject land is currently

zoned R1 General Residential under Guyra LEP 2012. No change in zoning or

development standards is proposed or needed in association with the reclassification.

Recommendation:

1. Prior to undertaking public exhibition, Council is to update the project timeline within the planning proposal to reflect that Council has been issued with plan making delegation for this planning proposal. Council is to update the planning proposal to reference the correct property description for the subject land, being Lot 131 DP 612522 instead of Lot 13

2. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:

(a) the planning proposal must be made publicly available for a minimum of 28 days; and

(b) the relevant planning authority must comply with the notice requirements for public

exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013).

- 3. No consultation is required with public authorities under section 56(2)(d) of the EP&A Act.
- 4. A public hearing is not required to be held into the matter under section 56(2)(e) of the EP&A Act. However, a public hearing is required to be held into the matter in accordance with the department's practice note PN09-003, as the planning proposal involves a reclassification of land from community to operational.
- 5. The timeframe for completing the LEP is to be 6 months from the week following the date of the Gateway determination
