PLANNING PROPOSAL TO MAKE VARIOUS AMENDMENTS TO GLEN INNES SEVERN LEP 2012 - GATEWAY DETERMINATION EXTENSION

PURPOSE

 To recommend the Minister's delegate alter the Gateway Determination for Planning Proposal PP_2013_GLENI_001_00.

RECOMMENDATION

It is RECOMMENDED that the Minister's delegate:

- agree pursuant to s56(7) of the Environmental Planning and Assessment Act, 1979, to amend the Gateway Determination to extend the time to complete the Planning Proposal to make various amendments to Glen Innes Severn LEP 2012 by six (6) months; and
- sign the letter to Council (Tag A).

CURRENT POSITION

- Council has prepared a Planning Proposal to amend Glen Innes Severn LEP 2012 to make corrections and amendments to the land zoning and lot size of certain land, permit with consent 'farm buildings' in the RU1 Primary Production Zone and permit without consent 'intensive plant agriculture' (excluding turf farming) in the RU1 Primary Production Zone.
- The Gateway Determination issued on 21 June 2013 (**Tag B**) required that the Planning Proposal be finalised in six (6) months from the week following the date of the Gateway Determination expiring on 28 December 2013.
- The Council has requested that the period to complete the proposal be extended for an additional six (6) months until 28 June 2014 (**Tag C**).
- The delay in meeting this Gateway Determination timeframe has arisen due to drafting issues with Parliamentary Counsel and their mapping requirements.
- The proposed timeframe extension request is considered to be appropriate and is supported.
