#### **PURPOSE**

To provide an update regarding the review of the Local Environment Plan (LEP), and to seek authorisation from Council to submit Planning Proposals for some of the proposed amendments to the LEP to the NSW Department of Planning and Environment (DPE) for their assessment and determination (Gateway).

#### SUPPORTING INFORMATION

Five (5) draft Planning Proposals. (Distributed under separate cover).

#### **BACKGROUND**

Council staff are currently completing a review of the LEP in line with Council's statutory obligations and commitment under the 2018-19 Operational Plan. An assessment of all Expressions of Interests (EOIs) for changes to the LEP has now been finalised and was based on the following criteria:

- Consistency with Council's adopted Growth Management Strategy (GMS);
- Consistency with State and local planning statutes;
- Suitability of the proposal in respect to environmental constraints (e.g. bushfire risk and flooding), land use conflict, access, the fragmentation of rural land, and the availability of public infrastructure and services;
- Proximity to town;
- Environmental protection (i.e. capacity to deliver urban development without excessive removal of vegetation);
- Riparian protection;
- Unique offering of the property; and,
- Sterilisation of future uses (i.e. suitability for other land uses).

# Council Staff have also completed the following

- Prepared five (5) draft Planning Proposals to support the 'routine' type matters that can be facilitated separately from the Local Strategic Planning Statement (LSPS) process;
- Identified the EOIs that will require more strategic justification and will therefore be considered further as a part of preparing a LSPS; and,
- Identified the unsuccessful EOIs due to not meeting the assessment criteria, as outlined above.

#### **ISSUES & COMMENTS**

Five (5) draft Planning Proposals to support the housekeeping amendments to the LEP have been prepared in accordance with NSW DPE's *Guide to Preparing Planning Proposals'* and *'Guide to Preparing Local Environmental Plans'*. The draft Planning Proposals have also been prepared as per the requirements under Section 3.33 of the *Environmental Planning and Assessment Act* (EP&A Act).

The Planning Proposals have been grouped based on the locality to which the EOIs relate to and/or commonality in the requested changes, as follows:

- Currabubula this Planning Proposal requests the rezoning of certain lands in Currabubula. The corresponding minimum lot size for the lands affected by this Planning Proposal is also sought to be reduced in order to facilitate future rural-residential development, and reflect existing and surrounding land use patterns;
- Dwelling opportunities this Planning Proposal seeks to allocate dwelling entitlements for six (6) allotments that do not currently have an opportunity to build a dwelling under the existing LEP framework;
- Heritage this Planning Proposal seeks to correctly identify, update and describe items of heritage significance in the Local Government Area. In addition, this Planning Proposal seeks to remove four (4) items of local heritage significance, add two (2) items of State heritage significance, and establish heritage conservation areas in Werris Creek and Quirindi;
- Piallaway & Wallabadah E4 rezonings this Planning Proposal seeks to rezone and reduce the minimum lot size of certain lands located to the north-west of Currabubula and to the south of Wallabadah;
- Quirindi & Werris Creek miscellaneous this Planning Proposal seeks to rectify zoning and minimum lot size anomalies, and to request the rezoning and minimum lot size reduction of certain lands in Werris Creek and Quirindi in order to facilitate future development opportunities.

The abovementioned Planning Proposals and associated maps are attached at the end of this Report for the information of Council.

It is proposed to use Council's local plan-making authority under the EP&A Act to make the amendments to the LEP. This has been included within the recommendation for this Report, and, if agreed to, will be sought when the draft Planning Proposals are forwarded to NSW DPE for their assessment and Gateway determination. The Gateway determination issued by NSW DPE will confirm whether Council has been authorised to make the proposed amendments to the LEP.

Following the outcomes of Council's consideration of this matter at their June Ordinary Meeting, all landholders who submitted an EOI will be informed about the progress of the LEP review and the status of their EOI. The landholders will be advised whether their EOI has been: progressed as a part of a draft Planning Proposal, deferred to the LSPS process, or will not proceed in this instance. This determination has been based on the EOI assessment criteria previously outlined in this Report. Landholders will be notified via email, letters and/or telephone call.

# FINANCIAL AND RESOURCE IMPLICATIONS

The LEP review has been undertaken in accordance with Council's corresponding budgetary allocation for the Project. Any specialist studies, such as a flora and fauna impact assessment and/or a contamination assessment, that may be requested by DPE to support the proposed amendments to the LEP will be required to be undertaken at the landholder's expense.

## **LEGAL IMPLICATIONS**

The draft Planning Proposals have been prepared in accordance with the requirements under the EP&A Act. There are no other known legal implications.

#### STAKEHOLDER CONSULTATION

Community consultation is a statutory requirement for the preparation of an amendment to the LEP. The duration and process for this consultation will be determined as part of the DPE's Gateway determination but is ordinarily a minimum of twenty-eight (28) days. The draft planning proposals attached to this Report recommend an exhibition period of twenty-eight (28) days via an advertisement in the local newspaper, fixed exhibits in Council's administration office and public libraries, Council's website and on social media. Targeted consultation will also be carried out the landholders that are affected by the Planning Proposals.

Consultation will also be required to be carried out with any other relevant Government Agencies, as required by DPE's Gateway determination. It is expected that this may include the NSW Rural Fire Service, the NSW Roads and Maritime Service, and the Australian Rail Track Corporation.

As also mentioned in this Report, the landholders who submitted an EOI will be informed about the progress and status of their EOI for the LEP review.

# **OPTIONS**

- 1. Confirm authorisation for Council staff to proceed with the lodgement of the presented draft Planning Proposals to amend the LEP to the NSW Department of Planning and Environmental for their assessment and determination; or,
- 2. Elect not to proceed with the draft Planning Proposals.

## **CONCLUSION**

Council staff have finalised the assessment of all EOIs that were received as a part of the review of the LEP. Flve (5) draft Planning Proposals are presented to Council for consideration. Authorisation is also sought from Council to forward the five (5) draft Planning Proposals to NSW DPE for their assessment and Gateway determination, and to use Council's local plan-making authority under the EP&A Act.
