Blacktown Local Environmental Plan 2015 (Amendment No. 2) – To rezone part of the former Department of Education 'Denis Winston Drive' site at 44 Tallawong Avenue, Doonside (Lot 1268 DP 803528) to E2 Environmental Conservation

I refer to Blacktown City Council's submission under the *Environmental Planning and Assessment Act 1979* (the Act), requesting that the Minister make Blacktown Local Environmental Plan 2015 (Amendment No. 2) (the Plan).

To finalise the Plan and address concerns from the landowner in regard to the development application before Council, under section 59(3) of the Act, I have amended the Plan to defer the area affected by the development application other than the area to be retained as residential zone as identified in Council's planning proposal.

The amended Plan is considered to be consistent with the intent and purpose of the Gateway determination. The amended Plan does not alter the intent of the proposal and enables Council to finalise the assessment of the development application under Blacktown Local Environmental Plan 2015.

The amended Plan will not remove Council's ability to assess the development under Clause 7.2 Terrestrial Biodiversity of Blacktown LEP 2015 to ensure comprehensive flora and fauna assessment and that the development incorporates measures to protect and minimise impacts on areas with significant biodiversity value.

Once the development application has been finally determined a planning proposal for the deferred area can be progressed that appropriately reflects the outcomes of that application.

I am pleased to advise that, as delegate of the Greater Sydney Commission, I have made the Plan under section 59(2) of the Act, and under section 34(5) of the Act it will take effect when published on the NSW Legislation website.
