Planning proposal to amend Blue Mountains Local Environmental Plan 2005 (Amendment 27)

I am writing in response to your Council's letter dated 2 January 2013 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to rezone land at 2-4, 6-10 and 14 Queens Road, Leura from Living - Bushland Conservation to Living - General and rezone land at 171 Great Western Highway, Leura to Regional Transport Corridor - Road.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

It is noted that the subject site is adjacent to the Blue Mountains District Anzac Memorial Hospital. As both sites are currently zoned Living - Bushland Conservation, Council may wish to also consider rezoning the site of the hospital to Living - General. Should Council agree with this suggestion, it is to ensure that the owners of the site are consulted directly, during the public exhibition of the planning proposal.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending LEP is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the department for administrative purposes.

Gateway Determination

Planning proposal (Department Ref: PP_2013_BLEUM_001_00): to rezone land at Leura for residential and road infrastructure purposes.

I, the Acting Director General, Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to the Blue Mountains Local Environmental Plan (LEP) 2005 to rezone land at 2-4, 6-10 and 14 Queens Road, Leura from Living - Bushland Conservation to Living - General and rezone land at 171 Great Western Highway, Leura to Regional Transport Corridor - Road should proceed subject to the following conditions:

- 1. Council is to consult with the NSW Rural Fire Services as per the requirements of S117 Direction 4.4 Planning for Bushfire Protection and amend the planning proposal, if necessary, to take into consideration any comments made prior to undertaking public exhibition.
- 2. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
 - (a) the planning proposal must be made publicly available for 28 days; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning & Infrastructure 2012).
- 3. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act:
 - NSW Rural Fire Service
 - Sydney Catchment Management Authority
 - Office of Environment and Heritage
 - Transport for NSW Roads and Maritime Services

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material. Each public authority is to be given at least 21 days to comment on the proposal, or to indicate that they will require additional time to comment on the proposal. Public authorities may request additional information or additional matters to be addressed in the planning proposal.

4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).



5. The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination.
