### Planning proposal to amend Auburn Local Environmental Plan 2010

I am writing in response to your Council's letter dated 28 March 2014 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to rezone land bounded by Auburn Road, Susan Street, Helena Street and Beatrice Street, Auburn from R3 Medium Density Residential to R4 High Density Residential and B4 Mixed Use, increase the maximum building height to 16m for land proposed to be zoned R4 and 21m for land proposed to be zoned B4 and amend the maximum floor space ratio to 1.4:1 for land proposed to be zoned R4 and 2.25:1 for land proposed to be zoned B4.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

## **Gateway Determination**

**Planning proposal (Department Ref: PP\_2014\_AUBUR\_001\_00)**: to rezone land at Auburn for residential and mixed use purposes and amend applicable development standards.

I, the General Manager, Metropolitan Delivery at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the EP&A Act that an amendment to the Auburn Local Environmental Plan (LEP) 2010 to rezone land bounded by Auburn Road, Susan Street, Helena Street and Beatrice Street, Auburn from R3 Medium Density Residential to R4 High Density Residential and B4 Mixed Use, increase the maximum building height to 16m for land proposed to be zoned R4 and 21m for land proposed to be zoned R4 and 2.25:1 for land proposed to be zoned B4 should proceed subject to the following conditions:

- The Traffic, Transport and Accessibility Study (August 2013) is to be updated to reflect the cumulative traffic impacts associated with this proposal and the notification of Auburn LEP Amendment No. 8. The Traffic Transport and Accessibility Study and Urban Design Study (August 2012) should also be updated to reflect that Auburn LEP Amendment No. 8 has been made, and the studies are to be placed on public exhibition with the planning proposal.
- Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
  - (a) the planning proposal must be made publicly available for a minimum of **28 days**;
  - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning and Environment 2013).
- 3. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act:
  - NSW Education and Communities
  - Office of Environment and Heritage
  - Department of Family and Community Services
  - Energy Australia
  - NSW Health
  - NSW Police Force
  - Transport for NSW
  - Roads and Maritime Services
  - Sydney Water
  - Fire and Rescue NSW
  - Adjoining Local Government Areas

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).



5. The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination.
