Planning Proposal PP_2013_WAGGA_001_00 – Gateway Determination extension

I refer to your request on 29 October 2013 seeking an extension of time to complete the Planning Proposal PP_2013_WAGGA_001_00 to rezone land at Collingullie Village; Barrington Street, Tatton; Tarcutta Street, Wagga Wagga; Estella, Wagga Wagga; Edward Street, Wagga Wagga and to make associated changes to the Lot Size Map, Height of Buildings Map, and Flood Space Ratio Map.

I have determined as the delegate of the Minister, in accordance with section 56(7) of the Environmental Planning and Assessment Act, 1979, to amend the Gateway Determination dated 27 March 2013 for PP_2013 WAGGA 001 00.

The Gateway Determination is amended by extending the time for the completion of the Planning Proposal by an additional 3 months. The Planning Proposal is now due for completion by 4 April 2014.

Council should aim to commence the exhibition of the Planning Proposal within four weeks from the week following this revised determination. Council's request for the Department to draft and finalise the LEP should be made six weeks prior to the projected publication date.

Amending Gateway Determination
