Planning Proposal PP_2013_WAGGA_002_00 – Gateway Determination Extension

I refer to your request on 29 August 2013 seeking an extension of time to complete the Planning Proposal PP_2013_WAGGA_002_00 to exclude complying development from the Lloyd Urban Release Area under Wagga Wagga LEP 2010.

I have determined as the delegate of the Minister, in accordance with section 56(7) of the Environmental Planning and Assessment Act, 1979, to amend condition 5 of the Gateway Determination to change the timeframe to complete the proposal from 6 months to 9 months.

The Gateway Determination is amended by extending the time for the completion of the Planning Proposal by an additional 3 months. The Planning Proposal is now due for completion by 11 January 2014.

The Local Environmental Plan (LEP) is to be finalised within 9 months of the week following the date of the original Gateway Determination.

Council's request for the Department to draft and finalise the LEP should be made six weeks prior to the projected publication date.
