Dear Mr Cairney

Planning proposal to amend Oberon Local Environmental Plan (LEP) 2013 (Amendment 4) (PP\_2015\_OBERO\_002\_00) to insert model boundary adjustment clause for rural and environmental zoned land.

I am writing in response to your Council's email dated 18 September 2015 requesting a Gateway determination in respect of the planning proposal to amend the Oberon Local Environmental Plan (LEP) 2013 to insert a model boundary adjustment clause to allow boundary adjustments for rural and environmental zoned land.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway Determination (**Attachment 1**).

The Minister delegated plan making powers to Councils in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of the planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan (**Attachment 2**).

The amending Local Environmental Plan (LEP) is to finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office (parliamentary.counsel@pco.nsw.gov.au) 10 weeks prior to the projected publication date.

A copy of the request should be forwarded to the Department of Planning and Environment (westernregion@planning.nsw.gov.au) for administrative purposes.

State Government is committed to reducing the time taken to complete LEP's by tailoring the steps in the process to the complexity of the proposal, and by providing clear and

publically available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the Environmental Planning and Assessment Act 1979 if the time frames outlined in the determination are not met.

In accordance with "A guide for the preparation of local environmental plans", Attachment 5 – Delegated plan making reporting template (**Attachment 3**) is enclosed for Council's information. Table 2 of the attachment is to be completed and included in Council's section 59 submission and forwarded to the <a href="westernregion@planning.nsw.gov.au">westernregion@planning.nsw.gov.au</a> when requesting the planning proposal to be finalised.

# **Gateway Determination**

Planning proposal (Department Ref: PP\_2015\_OBERO\_002\_00): to amend the Oberon Local Environmental Plan 2013 to insert model boundary adjustment clause to allow boundary adjustment for rural and environmental zoned land.

I, the General Manager, Western Region at Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the Environmental Planning and Assessment Act 1979 to amend the Oberon Local Environmental Plan 2013 to allow boundary adjustment for rural and environmental zoned land.

- Community consultation is required under sections 56(2)(c) and 57 of the Environmental 1. Planning and Assessment Act 1979 (EP&A Act) as follows:
  - The planning proposal is required to be made publicly available on exhibition for 28 (a) days as described in A Guide to Preparing LEPs (Department of Planning and Infrastructure 2012).
  - the relevant planning authority must comply with the notice requirements for public (b) exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs.

No consultation is required with public authorities under section 56(2)(d) of the EP&A Act.

- 2. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- The timeframe for completing the LEP is to be 9 months from the week following the date of 3. the Gateway determination.
