Subject: Extension of Gateway timeframe for various planning proposals

I refer to Council's requests dated 12 and 20 November 2013, seeking an extension of time to complete planning proposals for land in Menangle Street, Picton (PP_2012_WOLLY_001_00), land between Tahmoor and Thirlmere (PP_2011_WOLLY_011_00) and land in Bronzewing Street, Tahmoor (PP_2012_WOLLY_008_00).

I note that an extension of time is also required for several other planning proposals, which have already been submitted to the Department for finalisation.

As delegate of the Minister for Planning and Infrastructure, I have, under section 56(7) of the *Environmental Planning and Assessment Act 1979*, altered the Gateway determinations by extending the timeframes under section 56(2)(f) of the Act for completion of the planning proposals, as indicated below:
