REQUEST TO NOT TO PROCEED WITH THE PLANNING PROPOSAL FOR PP 2011 TAMWO 003 00 - REZONE LAND FROM RE1 PUBLIC RECREATION TO **B5 BUSINESS DEVELOPMENT**

PURPOSE

To recommend the Minister's delegate alter the Gateway Determination in accordance with the s56(7) of the Environmental Planning & Assessment Act, 1979, to enable the Planning Proposal to not proceed.

RECOMMENDATION

It is RECOMMENDED that the Minister's delegate:

- alter the original Gateway Determination under s56(7) of the Act to enable the Planning Proposal to not proceed; and
- signs the letter to the Tamworth Regional Council (Tag A).

CURRENT POSITION

- Tamworth Regional Council has written to the Department of Planning and Infrastructure requesting that the Planning Proposal not proceed (Tag B) for the following reasons:
 - constraints associated with access to the site; and
 - constraints associate with impact of flooding on the site and subsequent impacts on neighbouring properties.
- On 16 August 2011, the Deputy Director General issued the Gateway Determination for this Planning Proposal (Tag C) to rezone the land from RE1 Public Recreation to B5 Business Development to facilitate the development of bulky good premises.
- The request to not proceed with the Planning Proposal is supported as investigations have identified that the land is not suited for rezoning due to constraints relating to access and flooding.

BACKGROUND

- Council's Planning Proposal identified the site as potentially being subject to flooding.
- The Gateway Determination required further analysis of flooding of the site.
- Community concern over this rezoning was mixed due to the perceived disadvantage it would impose upon the Riding for the Disabled Association who utilise the existing facilities and would potentially have to relocate.
