### Assessment

Item A028 stone pitched embankment is listed twice in Part 3 Archaeological sites of Schedule 5 Environmental heritage – once with the correct property description, and once with the incorrect property description. It is shown only once on the Heritage Map - in the correct location.

### Recommendation

That LEP text Schedule 5 *Environmental heritage*, Part 3 *Archaeological sites* be amended by omitting the last entry, being the second listing of Item A028 at Yarras.

## Item No 23

#### Issue

Inclusion of a Floor Space Ratio Map was added during drafting of the LEP, and missed out on the same level of internal review prior to exhibition. It has been identified that a FSR of 0.65:1 has been applied to land zoned B5 Business Development, and it is considered that this is unnecessarily restrictive.

#### Location details

The B5 Business Development zone is used at three locations, particularly to permit bulky goods premises, within Port Macquarie, at Hibbard, Bellbowrie and Land Road. Shown on LEP map grid sheets 013 (or 013C), 013F, 013G.

## Assessment

For some development within the B5 Business Development zone a maximum floor space ratio of 0.65:1 may not be an issue, particularly after allowance for external parking and landscaping areas. However, it may unnecessarily restrict development, which will be subject to other considerations, including height. While a larger FSR could be applied, it is suggested that the FSR restriction could be removed within the B5 zone areas



## Recommendation

That the LEP Floor Space Ratio Map (on sheets FSR\_013, FSR\_013F and FSR\_013G) be changed to remove any maximum FSR for land zoned B5 Business Development.
