Re: Planning Proposal for Liverpool Local Environmental Plan 2008 (Amendment No. 20)

I am writing to you to advise that at its meeting held on 20th December 2010, Council resolved to amend the Liverpool Local Environmental Plan (LEP) 2008. The draft Liverpool Local Environmental Plan 2008 (Amendment No. 20) is to rezone land at 2A Moorebank Avenue and 7-15 Heathcote Road, Moorebank from R2 Low Density Residential to B6 Enterprise Corridor.

At its meeting council resolved to:

 Prepare and exhibit an amendment to the Liverpool Local Environmental Plan 2008 (Amendment No. 20), to rezone the subject land from R2 Low Density Residential to B6 Enterprise Corridor.
