Dear Mr Lamont

Planning proposal (PP\_2015\_NARRO\_004\_00) to rezone land and reduce the minimum lot size on part Lot 174 DP 755131, Old Backwater Road, Narromine - Alteration of Gateway determination - satisfying condition No 1 and inclusion of model clause to permit subdivision of split zones.

I refer to the planning proposal seeking to alter the Narromine Local Environmental Plan 2011 (LEP) in relation to land at Old Backwater Road, Narromine which was determined on 26 June 2015 and altered on 3 November 2015.

In accordance with Council's request in letter dated 11 December 2015, I am altering the Gateway Determination to address Council's intent to include a model clause in the Narromine LEP 2011 regarding subdivision of land that has more than one zone and minimum lot size that cannot be subdivided under the provisions of clause 4.1. This will facilitate the intent of the proposed rezoning and subdivision of the subject land.

An Alteration of Gateway determination is enclosed for your reference. This is to be read in conjunction with the previous Gateway determination dated 26 June 2015 and as altered on 3 November 2015. Please note there has been no change to the finalisation date being no later than 2 September 2016.

I also advise that the information provided indicating the area of land proposed to be rezoned has been reviewed and adequately satisfies the requirements of Condition 1 of the Gateway determination dated 3 November 2015. It is advised that approval is granted to allow the planning proposal to progress to community consultation.

Please include this letter, Gateway determinations and Council's correspondence of 23 November 2015 and 11 December 2015 as part of Council's community consultation package. Please ensure that the community consultation material clearly explains what is being proposed for this LEP amendment.
