## PLANNING PROPOSAL – ARTISAN FOOD AND DRINK INDUSTRY

At the Council meeting held on Thursday 15 October 2020, Council resolved to forward a Planning Proposal (enclosed) to the NSW Department of Planning, Industry & Environment and request a Gateway Determination.

This Planning Proposal seeks to include *artisan food and drink industry* as a permissible land use with consent within B2 Local Centre Zone to support the vitality of the Tumut town centre and to uplift the overall economic profile of Tumut.

The Planning Proposal will allow artisan uses in the B2 Local Centre zone that will ensure artisan uses of varying scales and intensities have options in their location and development. This will in turn see a potential tourism benefit that enable artisan establishments to take advantage of.

Accordingly, Snowy Valleys Council requests a Gateway Determination on the Planning Proposal from the Minister for Planning in accordance with Section 3.34 of the Environmental Planning & Assessment Act 1979 (EP&A Act). It is also requested that Snowy Valleys Council receive written authorisation to exercise delegation and the functions of the Minister for Planning under Section 3.36 of the EP&A Act.

Snowy Valleys Council considers the planning proposal not to be a 'low impact proposal', and accordingly, for the purposes of public exhibition would be seeking a public exhibition period for a minimum of 28 days (applicable to all other planning proposals).
