## **RE: PLANNING PROPOSAL (REZONING) FOR 20 MACQUARIE ST PARRAMATTA**

Thank you for the further opportunity to review the Planning Proposal for 20 Macquarie St Parramatta ('Planning Proposal'), which intends to amend the *Parramatta Local Environmental Plan (PLEP) 2011*.

The NSW SES position on the Planning Proposal remains the same as that stated in the submission of 11 September 2018 (attached).

The NSW SES notes that the comments included in the amended Planning Proposal in relation to the NSW SES's submission and comparison to 180 George St Parramatta (p 20); however this comparison was in relation to the further considerations necessary to ensure that the increase in flood risk at both sites is minimised as much as possible. It is acknowledged that the 180 George St differs in location and proximity to the river and proposed development when compared to 20 Macquarie St; however the risk to life is considered to be similar at both sites in severe floods. It is likely there are additional risks at 20 Macquarie St, considering the proposal for basement parking. The NSW SES submission of 11 September 2018 (attached) highlights the risks associated with basement parking in flash flood prone locations such as 20 Macquarie St.

Council will need to ensure the proponent or development application (DA) Applicant addresses the potential risks created by locating a development in a location that is considered to exhibit high flood risk in a probable maximum flood and that potentially exhibits high flood risk in floods below the PMF (although modelling is not available to be able to assess this). This includes but is not just limited to consideration of the risks with basement car parks in high flood risk environments as the amended Planning Proposal notes.
