ALTERATION OF GATEWAY DETERMINATION FOR PLANNING PROPOSAL PP 2016 BYRON 004 00

PURPOSE

 To recommend the Acting Director Regions, Northern as delegate for the Minister agrees to alter the Gateway determination for Planning Proposal no.
 PP_2016_BYRON_004_00 to permit a heliport at the Tyagarah Airport site and issue an Alteration of Gateway Determination.

RECOMMENDATION

- It is recommended that the Minister's delegate:
 - agrees under s56(7) of the Environmental Planning and Assessment Act 1979 to alter the Gateway determination for Planning Proposal no.
 PP_2016_BYRON_004_00 in accordance with the Alteration of Gateway Determination document at (Tab A), to extend the timeframe by a further six (6) months until 1 January 2018;
 - **agrees** under part 3, division 4 of the *Environmental Planning and Assessment Act 1979* that no additional community consultation is required;
 - **signs** the Alteration of Gateway Determination (<u>Tab A</u>); and
 - **signs** the letter to Byron Shire Council (<u>Tab B</u>).

CURRENT POSITION

- Council has prepared a Planning Proposal to amend Schedule 1 of the Byron Local Environmental Plan (LEP) 2014 to list 'heliport' as an additional permitted use and to amend the Lot Size map to apply a minimum lot size that enables subdivision which reflects the current lease boundaries.
- The Gateway determination issued on 24 March 2016 (<u>Tab C</u>) determined that the proposal should proceed subject to consultation with Office of Environment and Heritage, Department of the Commonwealth responsible for aerodromes and the Lessee of the aerodrome, NSW Roads and Maritime Services and NSW Rural Fire Service.
- The Gateway determination required that the Local Environmental Plan be finalised in nine (9) months from the week following the date of the Gateway determination expiring on 1 January 2017. An alteration was granted on 28 November 2016 to extend the completion date to 1 July 2017.
- The Council has requested that the period to complete the proposal be extended for a further six (6) months.
- The delay in meeting this Gateway determination timeframe has arisen due to the need to undertake additional studies to support the proposal.

• Community consultation occurred between 5 May 2016 and 2 June 2016. It is considered that the revised Planning Proposal does not require further community consultation as the changes only relate to the timeframe for completion.
