**Gateway Determination - Auburn Local Environmental Plan 2010
Amendment No. 15 – Floor Space Ratio Mapping Anomaly**

I am writing in response to Council's request for a Gateway determination for a planning proposal to correct a floor space ratio mapping anomaly for map FSR_002 of Auburn Local Environmental Plan 2010.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

The Minister delegated plan making powers to councils in October 2012. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

I have also agreed that the planning proposal's inconsistency with s117 Directions 1.1 Business and Industrial Zones and 3.1 Residential Zones, is of minor significance. No further approval is required in relation to these Directions.

The amending Local Environmental Plan (LEP) is to be finalised within 3 months of the week following the date of the Gateway determination. Council's request for the Department to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office six (6) weeks prior to the projected publication date. A copy of the request should be forwarded to the Department for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2014_AUBUR_004_00): to correct a floor space ratio mapping anomaly for land bounded by Alice, Queen, Mary Streets and Park Road, Auburn.

I, the Director, Metropolitan Delivery (Parramatta), at the Department of Planning and Environment, as delegate of the Minister for Planning, have determined under section 56(2) of the EP&A Act that an amendment to the Auburn Local Environmental Plan (LEP) 2010 to correct a floor space ratio mapping anomaly for land bounded by Alice, Queen, Mary Streets and Park Road, Auburn, to proceed subject to the following conditions:

1. Community consultation is not required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 (EP&A Act).
2. Consultation with the public authorities under section 56(2) of the AP&A Act is not required.
3. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example in response to a submission or if reclassifying land).
4. The time frame for completing the LEP is 3 months from the week following the date of the Gateway determination.
