PLANNING PROPOSAL - No. 2471 SILVERDALE ROAD, SILVERDALE

Council has resolved to support the preparation of a Planning Proposal to amend the land use zone and introduce a new minimum lot size on the site at Lot 43 DP 1126346 (No. 2471) Silverdale Road. At its ordinary meeting held on 19 June 2017, Council resolved the following:

- 1. That Council support the preparation of a Planning Proposal for land being Lot 43 DP 1126346 (No. 2471) Silverdale Road, Silverdale to amend Wollondilly Local Environmental Plan. 2011 as follows:
 - Amend the Land Zoning Map from SP2 Infrastructure Zone to E3 Environmental Management;
 - Amend the Lot Size Map to introduce a minimum lot size of 10 hectares across the entire site.
- 2. That the Planning Proposal be forwarded to the Greater Sydney Commission for a Gateway Determination.
- 3. That Council request the Greater Sydney Commission grant Council delegation to make the amendments to Wollondilly Local Environmental Plan, 2011 in accordance with Section 59 to the Environmental Planning and Assessment Act, 1979.
- 4. That the proponent and submitter be notified of Council's Resolution.

In accordance with the above resolution, Council requests the minister to grant delegation to make this amendment to WLEP 2011 in accordance with Section 59 of the Environmental Planning and Assessment Act, 1979 and relevant Planning Circulars.

Council also recommends that any Gateway Determination for the site require the following specialist studies to be undertaken:

- Preliminary Site Investigation to be undertaken in accordance with State Environmental Planning Policy No. 55 – Remediation of Land;
- Bushfire Hazard Assessment:
- Rural Land Use Conflict Assessment which considers the impact of the existing adjoining zone substation and nearby water chlorination plant.
