

Gateway Determination

Planning Proposal (Department Ref: PP_2017_LISMO_006_00): to make various housekeeping amendments to Lismore LEP 2012.

I, the Director Regions, Northern, at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act, 1979* (the Act) that an amendment to the Lismore Local Environmental Plan (LEP) (2012) to make various housekeeping amendments should proceed subject to the following conditions:

- 1. The planning proposal is to be updated prior to community consultation to:
 - a) update Table 1 remove reference to Item I maps and add reference to Item G maps;
 - b) change the reference from SEPP (Exempt and Complying Development Code) 2008 to SEPP (Educational Establishments & Child Care Facilities) 2017;
 - c) correct the Lot Size Map reference for Item F maps from LSN to LSZ;
 - d) update Appendix 3 (2.3 Heritage Conservation) to reflect the correct alphabetic label (Item J);
 - e) update Appendix 3 to reflect the consistency with 5.3 Farmland of State and Regional Significance on the NSW Far North Coast;
 - f) update Appendix 3 to reflect s117 Direction 5.10 Implementation of Regional Plans.
- 2. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal must be made publicly available for a minimum of **28** days; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in Section 5.5.2 of *A guide to preparing local environmental plans* (Department of Planning and Environment 2016).
- 3. Consultation is required with the following public authorities under section 56(2)(d) of the Act and/or to comply with the requirements of relevant Section 117 Directions:
 - NSW Rural Fire Service
 - Office of Environment and Heritage
 - Local Aboriginal Land Council

Each public authority is to be provided with a copy of the Planning Proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.



- 4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 5. The timeframe for completing the LEP is to be **12 months** following the date of the Gateway determination.

Planning Proposal PP_2017_LISMO_006_00 to amend Lismore Local Environmental Plan 2012

I am writing in response to Council's request for a Gateway determination under Section 56 of the *Environmental Planning and Assessment Act 1979* (the Act) in respect of the Planning Proposal to make various housekeeping amendments to Lismore LEP 2012.

As delegate of the Minister for Planning, I have now determined the Planning Proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed, as delegate of the Secretary, the Planning Proposal's inconsistencies with Section 117 Direction 3.1 Residential Zones and 6.2 Reserving Land for Public Purposes are justified in accordance with the terms of the Directions. No further approval is required in relation to these Directions.

Council may still need to obtain the agreement of the Department's Secretary to comply with the requirements of relevant Section 117 Direction 4.4 Planning for Bushfire Protection. Council should ensure this occurs prior to the plan being made.

Plan making powers were delegated to Councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the

projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under Section 54(2)(d) of the Act if the time frames outlined in this determination are not met.
