Planning Proposal PP_2016_CGREG_001_00 (formerly PP_2016_GUNDA_001_00) – Alteration of Gateway Determination.

I write regarding Council's request of 19 December 2016 for an amended Gateway determination in relation to Planning Proposal PP_2016_GUNDA_001_00 to amend the land use table for the IN3 (Heavy industrial) zone and remove Item No.46 from Schedule 5 of the Cootamundra LEP 2013.

I note Council now seeks to revise the planning proposal to include 'Serviced Apartments' as being permissible with consent in the R1 General Residential zone.

I have determined as the delegate of the Minister, in accordance with section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 27 October 2016 for PP_2016_001_00. The Alteration of the Gateway Determination is enclosed.

Further, as part of this amended Gateway determination, and as consequence of the initial naming of the merged Cootamundra and Gundagai Councils to Gundagai Council, a resulting system error has been identified whereby two separate planning proposals share the same planning proposal reference number. Subsequently the Department has amended its systems and corrected the duplication to avoid any future confusion during the planning proposal process. This planning proposal, for which a gateway determination was originally issued on 27 October 2016, now has a new Planning Proposal number being PP_2016_CGREG_001_00.
