REQUEST FOR EXTENSION TO TIMEFRAMES OF PLANNING PROPOSALS FOR SILVERDALE & ST HELIERS ROAD, LAND ADJOINING OAKDALE SPORTSFIELDS, PTTAG, ARGYLE STREET BUSINESS LANDS, STARGARD CRESCENT, MONTPELIER DRIVE RESIDENTIAL LANDS, MACQUARIEDALE ROAD, ABBOTSFORD, BULLI-APPIN ROAD, LAND ADJOINING OAKDALE PUBLIC SCHOOL,

Land Between Tahmoor & Thirlmere (PTTAG) (PP_2011_WOLLY 011 00)

Gateway Determination:

14 September 2011

<u>Timeframe for completion:</u> 12 months from the week following the date of the Gateway Determination, being 21 September 2012. Since that time this planning proposal has received several extensions and the gateway timeframe now expires on 21 December 2014.

Current Status:

This Planning Proposal has been with the Department since late July 2014 for finalisation, but is yet to receive an Opinion that the plan can be made from Parliamentary Counsel's Office. Council does not have delegation for this proposal.

Argyle Street Business Development Lands (PP_2013_WOLLY_007_00)

Gateway Determination:

20 June, 2013

18 months from the week following the Gateway Determination (27

December, 2014)

<u>Current Status:</u> Government Agency Consultation was carried out in July, 2013. Responses were received from the relevant government agencies. The responses received from the Mine Subsidence Board and Department of Trade and Investment were against the proposal proceeding as the site will be subject to undermining within the next 6-7 years.

The NSW Department of Trade and Investment in their response of 28 August, 2013 stated that as the site location lies above an approved longwall mining project area and there is potential for future subsidence in this location, MRB does not support the planning proposal until mining in this area has been completed."

Council resolved at its ordinary meeting on 18 November, 2013 to request advice from the Director General of the Department of Planning as to whether a study would assist in providing suitable design and engineering guidelines for future development that would overcome or minimise potential subsidence impact.

Advice was received from the NSW Department of Planning and Infrastructure on 26 February, 2014 who stated that they had carried out consultation with Department of Trade and Investment and Mine Subsidence Board who confirmed their objection to the proposal until undermining of the site had been completed, however both agencies have indicated their willingness to consider a study by Council. Further consideration will be given to the planning proposal and consistency with relevant ministerial directions if and when the study is received.

Land Adjoining Oakdale Public School, Oakdale (PP_2013_WOLLY_004_00)

Gateway Determination:

<u>Timeframe for completion:</u> 12 months from the week following the date of the Gateway Determination (11 April 2014).

Current Status:

Specialist studies were prepared and submitted to Council in December, 2013 and consultation with government agencies was carried out in March, 2013. These agencies included Office of Environment and Heritage, Sydney Catchment Authority, Rural Fire Service, Department of Education and Communities, NSW Heritage Office, Sydney Water, Roads and Maritime Service and Endeavour Energy. Responses were provided and consultation was on-going until January, 2014 with a view to addressing the concerns raised in the agency responses.

The Gateway Determination also included a condition to consider the rezoning of rural land to the immediate east of the subject site to ensure that an isolated pocket of rural land is not created by the Planning Proposal. In May, 2014 Council resolved to support the inclusion of the additional land to the immediate east of the site following consultation with the Department of Education and Communities and Oakdale Public School. In September, 2014 an altered Gateway Determination was issued by the Department of Planning to include the additional land in the Planning Proposal. A report will be considered by Council at its meeting of December, 2014 to endorse the final form of the planning proposal before proceeding to exhibition. If the final form of the planning proposal is

endorsed by Council then the proposal will be sent to the Department of Planning before proceeding to exhibition.
