## Planning proposal (Department Ref: PP\_2014\_BALLI\_002\_00)

I, the General Manager, Northern Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979 ("EP&A Act")* to alter the Gateway Determination dated 10 April 2014, for the proposed amendment to the Ballina Local Environmental Plan 2012 as follows:

1. Changing the description of the Planning Proposal
