## DUBBO CITY COUNCIL - PLANNING PROPOSAL (PP\_2016\_DUBBO\_001\_00) – AMEND FLOOR AREA PROVISIONS FOR SECONDARY DWELLINGS

Thank you for writing to me on 8 February 2016 regarding authorisation to exercise delegation to carry out the Ministers plan making functions under section 59 of the Environmental Planning and Assessment Act, 1979 for the subject planning proposal which seeks to amend the Dubbo Local Environmental Plan 2011.

As delegate of the Minister for Planning, I have given further consideration to the nature of the amendment and Council's request for the Minister to retain plan making powers. I have determined that it is appropriate in this instance for the authorisation to exercise delegation, issued with the Gateway determination on 13 January 2016 be revoked.

This letter is to be taken as formal advice revoking authorisation for Dubbo City Council to exercise delegation to carry out the Minsters plan making functions for the subject planning proposal (PP\_2016\_DUBBO\_001\_00). An Alteration of Gateway determination is enclosed to reflect this decision. All conditions of and timeframe for the Gateway determination remain.
