Submission of Revised Planning Proposals – PP_2013_WAGGA_004_00 and PP_2012_WAGGA_007_00 to amend Wagga Wagga Local Environmental Plan 2010 (WWLEP)

Two planning proposal have received Gateway Determination for the following areas:

- PP_2012_WAGGA_007_00 3870 Sturt Highway, Gumly Gumly Gateway Determination received 2 November 2011
- PP_2013_WAGGA_004_00 Gumly Gumly Precinct Gateway Determination received 9 July 2013

The original proposal areas and revised proposal areas are shown in the map below:





The revision results in the addition of lots to be rezoned as part of the precinct planning proposal. These additional areas have not been considered as part of the original Gateway Determination.

On 27 May 2019 at the Council Meeting, Wagga Wagga City Council (WWCC) resolved to send the attached revised planning proposals to the Department of Planning and Infrastructure for a revised Gateway Determination to amend the WWLEP 2010.
