Alteration of Gateway Determination

Planning proposal (Department Ref: PP_2012_WAGGA_007_00)

I, the General Manager, Southern Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 2 November 2012 (as since altered) for the proposed amendment to the Wagga Wagga Local Environmental Plan 2010 as follows:

1. Delete:

Condition 5 "The timeframe for completing the Local Environmental Plan is to be 24 months from the week following the Gateway determination"

And replace with:

A new condition 5 "The timeframe for completing the LEP is to be 30 months from the week following the date of the Gateway determination"

2. Insert:

New condition 6 "Further community consultation is required for the altered planning proposal under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:

- (a) the planning proposal is classified as low impact as described in A Guide to Preparing LEPs (Department of Planning and Environment 2013) and must be made publicly available for a minimum of 28 days; and
- (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning and Environment 2013)."

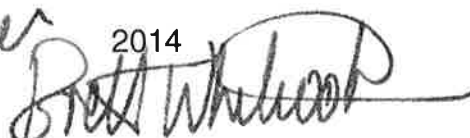
