## PLANNING PROPOSAL – 4 McCAUSLAND PLACE, KELLYVILLE

The Hills Local Environmental Plan 2012 (Amendment No. (#)) – to include a new clause in Schedule 1 – Additional Permitted Uses in LEP 2012 to permit 'residential flat buildings; to increase the maximum building height to 14 metres for the portion of the land where residential flat buildings will be permitted and inclusion of a new local provision that applies to land at 4 McCausland Place, Kellyville (5/2016/PLP)

Pursuant to Section 117(2) of the *Environmental Planning and Assessment Act 1979* (EP&A Act), it is advised that Council has resolved to prepare a planning proposal for the above amendment.

Please find enclosed the information required in accordance with the guidelines 'A guide to preparing planning proposals' issued under Section 55(3) of the EP&A Act. The planning proposal and supporting material is enclosed with this letter for your consideration. It would be appreciated if all queries by the Panel could be directed to Principal Forward Planner, Megan Munari on 9843 0407.

The planning proposal will facilitate the development of the site with a residential flat building comprising 20 dwellings on the south east corner of the site and fifteen townhouses on the remainder of the site. The development of the site will provide both high and medium density housing adjacent to a local centre, on an existing public transport route and will facilitate the delivery of the Arnold Avenue realignment and connection to the planned signalised intersection of Arnold Avenue and Memorial Avenue.

Pursuant to Clause 5(d) of Local Planning Direction 5.9 North West Rail Link Corridor Strategy, this Section 56 notification also seeks the concurrence of the Director General with respect to an inconsistency with of this Direction, as detailed in the attached Planning Proposal.
