Re: Planning Proposal (PP_2016_BATHU_001_00) to amend Bathurst Regional Local Environmental Plan 2014 – to alter the boundary of RE1, RU1 and R1 zoned land on Lot 11 DP 872964, Freemantle Road, Eglinton, Bathurst.

I am writing in response to Council's planning proposal dated 27 January 2016 and subsequent supporting information received on 8 February 2016 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 in respect of the subject matter.

As delegate of the Minister for Planning, I have determined the planning proposal should proceed subject to the conditions in the attached Gateway determination (Attachment 1).

I am satisfied that the inconsistencies with section 117 Directions 1.2 Rural Zones, 1.5 Rural Lands, 4.3 Flood Prone Land and 6.2 Reserving Land for Public Purposes are of minor significance. In relation to section 117 Direction 6.2, I also approve the proposed reduction in zone RE1 Public Recreation. No further approval or work is required in relation to these Directions.

It is noted that Council has not addressed SEPP 55 Remediation of Land and SEPP (Rural Lands) 2008 in context of this planning proposal. As both of these SEPPs apply to this proposal, Council needs to address these policies and include this with the community consultation material. The response to these policies also needs to be addressed as part of Council's section 59 submission.

The Minister delegated plan making powers to Councils in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan (Attachment 2). The LEP should be made directly to Parliamentary Counsel's Office (parliamentary.counsel@pco.nsw.gov.au) 10 weeks prior to the projected publication date.

A copy of the request should be forwarded to the Department of Planning and Environment (westernregion@planning.nsw.gov.au) for administrative purposes.

In accordance with "A guide for the preparation of local environmental plans", *Attachment 5 – Delegated plan making reporting template* is enclosed for Council's information. Table 2 of the attachment is to be completed and included in Council's section 59 submission and forwarded to the westernregion@planning.nsw.gov.au when requesting the planning proposal be finalised.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the Environmental Planning & Assessment Act, 1979 if the time frames outlined in this determination are not met.

Gateway Determination

Planning Proposal (Department Ref: PP_2016_BATHU_001_00) to amend Bathurst Regional Local Environmental Plan 2014 – to alter the boundary of RE1, RU1 and R1 zoned land on Lot 11 DP 872964, Freemantle Road, Eglinton, Bathurst.

I, the General Manager, Western Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the Environmental Planning and Assessment Act 1979 (EP&A Act) that the abovementioned planning proposal should proceed subject to the following conditions:

- 1. Prior to commencing community consultation, Council must address SEPP 55 Remediation of Land and SEPP (Rural Lands) 2008 and include a copy of the response with the consultation material. The response to these policies must also be addressed as part of Council's section 59 submission.
- 2. Community Consultation is required under sections 56(2)(c) and 57 of the EP&A Act as follows:
 - (a) the planning proposal must be made publicly available for a minimum of **28 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013).
- 2. Consultation is required with the following State Agencies under section 56(2)(d) of the EP&A Act:
 - (a) NSW Office of Water, and
 - (b) Office of Environment and Heritage.

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

- 3. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 4. The timeframe for completing the LEP is to be **nine (9) months** from the week following the date of the Gateway determination.
