Planning proposal to amend Liverpool Plains Local Environmental Plan 2011

I am writing in response to your Council's letter dated 6 April 2016 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 (the Act) in respect of the planning proposal to amend Liverpool Plains LEP 2011 to rezone land north of Quirindi for rural residential and environmental living purposes, introduce a rural boundary adjustment clause and permit farm buildings with consent on land zoned R5 Large Lot Residential.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed, as delegate of the Secretary, the planning proposal's inconsistency with S117 Direction 3.1 Residential Zones is justified in accordance with the terms of the direction. No further approval is required in relation to this Direction.

Council may still need to obtain the agreement of the Department's Secretary to comply with the requirements of relevant S117 Directions 2.1 Environmental Protection Zones and 4.4 Planning for Bushfire Protection after consultation with the NSW Office of Environment and Heritage and the NSW Rural Fire Service respectively. Council should ensure this occurs prior to the plan being made.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has now accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet

these commitments, the Minister may take action under section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2016_LPLNS_002_00): to amend Liverpool Plains LEP 2011 to rezone land north of Quirindi for rural residential and environmental living purposes, introduce a rural boundary adjustment clause and permit farm buildings with consent on land zoned R5 Large Lot Residential.

I, the Acting Director Regions, Northern at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Liverpool Plains Local Environmental Plan (LEP) 2011 to rezone land north of Quirindi for rural residential and environmental living purposes, introduce a rural boundary adjustment clause and permit farm buildings with consent on land zoned R5 Large Lot Residential, should proceed subject to the following conditions:

1. Prior to community consultation the following site investigations are to be conducted for the land at Quirindi North which is to be rezoned, and if necessary the planning proposal is to be amended to take into account the findings of these investigations:
 - (a) A noise assessment for the potential impact of noise from the rail corridor on future residential land uses;
 - (b) An Aboriginal cultural heritage assessment; and
 - (c) A preliminary contaminated land assessment for land adjacent to the former sanitary depot (shown zoned SP2 Waste or Resource Management Facility in the Liverpool Plains LEP 2011).

These investigations are to accompany the planning proposal for community consultation.

2. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal must be made publicly available for a minimum of **28 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs* (Department of Planning and Infrastructure 2013).

3. Consultation is required with the following public authorities under section 56(2)(d) of the Act and/or to comply with the requirements of relevant S117 Directions:

- NSW Roads and Maritime Services
- NSW Office of Water
- NSW Department of Primary Industries – Agriculture
- NSW Office of Environment and Heritage
- NSW Rural Fire ServiceFirst
- Australian Rail Track Corporation

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
5. The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination.
