Planning Proposal PP_2012_KEMPS_002_00 – Alteration of Gateway Determination

Alteration of Gateway Determination

Planning proposal (Department Ref: PP_2012_KEMPS_002_00)

I, the Acting Director Regions, Northern at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 8 October 2012 (as since altered) for the proposed amendment to the Kempsey Local Environmental Plan 2013 as follows:

- 1. Delete condition 6:
 - "6. The timeframe for completing the LEP is by 15 April 2017."

and replace with a new condition 6:

- "6. The timeframe for completing the LEP is by 15 April 2018."
- 2. Insert condition 8:
 - *8. Prior to undertaking further community consultation as required in condition 7, the revised planning proposal is to be amended as follows:
 - (a) change the references to R2 Low Density Residential to R1 General Residential in Figures 3 and 4, and the discussion relating to State Environmental Planning Policy (Rural Lands) 2008 and S117 Direction 1.2 Rural Zones; and
 - (b) include maps showing the existing and proposed Height of Buildings Map and Lot Size Map for the subject land."
