Background

Work on the Heritage Review was partially completed in 2010-11, at which time a number of additional studies were completed. This significant study relating to improving the heritage listings of the LGAs 'natural' areas was commissioned by Council in 2010 and carried out by consultant Dr Jim Smith. The work related to areas covered under Blue Mountains LEP 1991, which generally covers outlying areas of the LGA (not town centres). Council was undertaking an audit of the items contained in the heritage schedule of LEP 1991 (now repealed). The task aim was to "review the accuracy and validity of the information recorded against each item in the State Heritage Inventory Database". At the time, Council intended to consolidate LEP 1991 and LEP 2005 heritage schedules in order to create a consolidated heritage schedule in LEP 2005.

This introductory section forms the explanatory material to the spreadsheet prepared by the consultant that follows. No covering report was prepared.

Notes from the draft report of April 2012 by Blue Mountains City Council, reporting on the 2010 results of this study

Natural Area Listings and Cultural Landscape

The important aspects of natural heritage and cultural landscapes were only dealt with marginally in 1991 and 2000 and have now been expanded on in the recent heritage review. Most heritage studies in the past have concentrated on built heritage. For the first time, work was completed in 2010 by Dr Jim Smith which addressed the heritage listing of natural areas (predominantly walking tracks, cultural landscapes and other historic items). This work included the review of Council's heritage inventory forms and the proposal of new heritage items and heritage conservation areas which encompassed entire cultural landscapes. For example the cultural landscapes included walking tracks, lookouts, vegetation and historic relics i.e. coal mining relics. The work aimed to combine not only the natural elements of a historic place, but also the human influences that have occurred to the place over time.

Dr Smith's work also follows on from previous projects undertaken in conjunction with the National Parks and Wildlife Service to undertake a study and heritage list walking tracks of State heritage significance. Dr Smith's recent work provides nominations to heritage-list walking tracks that are of State and local heritage significance. The listing of heritage items in Dr Smith's work focused on Council owned/managed lands with some items identified traversing into the Blue Mountains National Park. [Note: The identification of heritage items/tracks entirely within the Blue Mountains National Park was outside the scope of this study].

Walking tracks are obviously of cultural significance to the Blue Mountains and should be preserved, celebrated and their continued use protected in some way. There are two key aspects to the significance of walking tracks – their historic fabric but also their historic route. Public rights of way,

such as those in England and Wales, provide statutory protection to historic footpaths, bridleways and byways. In Australia there is no similar statutory mechanism, apart from the complex issue of easements. In considering heritage listing of a historic walking track there are the typical criteria to consider such as historic, aesthetic, technical and social values. The following issues begin to address the reasons for heritage listing within the Blue Mountains:

- 1. To acknowledge highly significant historical, technical and social values.
- 2. To recognise and preserve the continuity of historic track routes where intact.
- 3. To conserve fabric of a historic walking track, the track may have been a significant early track and provide a degree of intactness of physical elements.
- 4. To guide appropriate context at key locations such as track heads.
- 5. To reinforce the relationship to significant lookouts, natural features or other associations.

Content of study

The study proposed a large number of new items. Some new items sought to consolidate multiple smaller listings into a new 'reserve' or 'heritage conservation area' and then delete the 'child' listings.

A large number of mapping changes were associated with the proposed changes.

A number of issues were raised by the study:

- 1. Many of the walking tracks cross private property, although generally accessible to the public and in some cases generally considered to be public tracks. Whilst heritage listing does not directly correlate with public access, the agreement of the owner to allow public access to continue over their land could be required and/or negotiated. This process could require the creation of legal easements and could be lengthy and time-consuming. Some owners would be legally entitled to fence off their land from public access, thereby blocking the track access path.
- 2. The large size of some of the proposed areas could potentially concern property owners (generally Council and Crown lands), in regard to their maintenance and minor works requirements for consent on land this comprehensively large, and this needed to be worked through with the property owners through consultation.
- 3. The enlarged scope of the heritage listing mapping over large reserves which required the deletion of 'child' items within the new 'parent' curtilage would cause the mapping of smaller 'child' items, to be lost ie. they would no longer be shown due to the large new curtilage.

2016 review of the study

The area of expertise held by the consultant is highly specialised and a challenge to peer review for values relating to cultural landscapes that are primarily natural bushland. Council's heritage experts

reviewed the standing recommendations. A precautionary approach was taken to progressing some of the more difficult, large or legally-complicated listings.

The recommendations of the 2010 study were reviewed in 2016. Some items were progressed and some items were deferred for a future stage of the Review on the following basis:

Some proposed listings were not progressed because:

- 1. The proposed new reserves or heritage conservation areas were too large in area to manage successfully. Some smaller sized reserves were included in this Review to gauge the response from land owners in terms of their concerns regarding management requirements.
- 2. Some listings where the significance was not clear, for example, heritage values or mapping boundaries, were deferred pending more information.
- 3. Tracks which passed over private land were considered difficult to progress due to the legal issues. In some cases where the sections of private property affected were very small, these parts of the track passing over private property were deleted from the mapping.
- 4. Tracks which passed through the urban streets of Mountains villages are not proposed to progress, for example, Bruce's Walk, due to the difficulty of mapping and managing development within these urban areas when heritage mapped as a walking track.
- 5. State nominations require a different process via a state nomination to the NSW Heritage Council.

The items indicated in the spreadsheet with grey background were not progressed in this Review due to the above criteria.
