Background and summary to supporting documents

Background

Work on the Heritage Review was partially completed in 2010-11. Part of this work was a gap analysis study carried out by Council to identify gaps in Council's inventory where properties were listed by other agencies.

A draft report was prepared by Council in April 2012 describing the gap analysis results and subsequent changes proposed as part of the Heritage Review work. This introductory section forms the explanatory material to the gap analysis schedule that follows.

PART 5 - GAP ANALYSIS

WHERE DO THE GAPS EXIST AND WHY?

To ensure completeness of this Review, a review of all other government agencies was undertaken to ensure that all items in the LGA were assessed and captured where necessary.

HERITAGE LISTINGS BY OTHER AGENCIES

A review of places regarded by other heritage agencies as culturally significant was undertaken as part of the overall gap analysis in listings within the Blue Mountains region. There are a number of government and non-government bodies with an interest in heritage in NSW and some compile and manage a list of places regarded by them as having some significance. There are also a number of lists with varying levels of significance compiled for places with World, National, State and Local significance. However, although not all 'listings' have a legal status, it is important to include the non-statutory bodies because they reflect broad community values, such as those places 'listed' by the National Trust of Australia, or might represent more specialised appreciation of significance, such as those places 'listed' by Australian Institute of Architects. In the past many of the smaller special interest groups maintained their own 'registers' such as the Professional Historians Association Register of Historic Places and Objects, the Geological Society Register and the Art Deco Society Register however the general direction today in NSW is towards more comprehensive listings either through the State Heritage Register or at the local level through Local Environment Plans.

This section comprises the gap analysis undertaken as a part of the Heritage Review and includes a brief overview of each heritage body and its interest, together with a comprehensive tabulation of places of significance identified by these groups of government agencies. The tabulation has been prepared with readily available information and it may be necessary to add to the tabulation as more information is made available by the smaller groups.

The following summary outlines the International bodies:

WORLD HERITAGE

The World Heritage Convention is a successful global instrument for the protection of cultural and natural heritage. The World Heritage Convention was adopted by the United Nations Educational, Scientific and Cultural Organisation (UNESCO) in 1972 and in August 1974, Australia became one of the first countries to ratify the Convention.

The World Heritage Convention aims to promote cooperation among nations to protect heritage around the world that is of such outstanding universal value that its conservation is important for current and future generations. The Convention establishes a list of properties that have outstanding universal value, called the World Heritage List. Inscription of a property on the World Heritage List can produce many benefits for Australia, and in particular, for local communities. World Heritage listing does not affect ownership rights. Ownership remains as it was prior to nomination. State and local laws still also apply. World Heritage properties in Australia do not become Commonwealth property, nor do they become the property of any international body or foreign power.

Australia's World Heritage properties comprise a wide variety of land tenures including freehold, perpetual lease, pastoral lease, town reserve, State forest, national park, nature reserve, Aboriginal reserve and recreational reserve. The Australian Government has an international obligation to protect and conserve World Heritage properties, but there is no impediment to existing land uses unless they threaten any of the outstanding universal values of the property.

There is 1 item within the Blue Mountains LGA listed on the World Heritage Register and this item is already included in Schedule 2 of Council's LEP 1991 as a heritage item.

AUSTRALIAN FEDERAL GOVERNMENT

The following summary outlines the Australian Government bodies:

National Heritage List

Australia's national heritage comprises exceptional natural and cultural places that contribute to Australia's national identity. National heritage defines the critical moments in our development as a nation and reflects achievements, joys and sorrows in the lives of Australians. It also encompasses those places that reveal the richness of Australia's extraordinarily diverse natural heritage.

The National Heritage List has been established to list places of outstanding heritage significance to Australia. It includes natural, historic and Indigenous places that are of outstanding national heritage value to the Australian nation. The National Heritage List is compiled and maintained by the Department of the Environment, Water, Heritage and the Arts and can be searched using the Australian Heritage Database. The Australian Heritage Council is the principal adviser to the Australian Government on heritage matters. The Council assesses nominations for the National Heritage List, and the Commonwealth Heritage List.

There are 3 items within the Blue Mountains LGA listed on the National Heritage List and these places are already included in Schedule 2 of Council's LEP 1991 as heritage items.

Commonwealth Heritage List

The Commonwealth Heritage List, established under the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act), comprises natural, Indigenous and historic heritage places which are either entirely within a Commonwealth area, or outside the Australian jurisdiction and owned or leased by the Commonwealth or a Commonwealth Authority; and which the Minister is satisfied have one or more Commonwealth Heritage values.

The Commonwealth Heritage List is compiled and maintained by the Department of the Environment, Water, Heritage and the Arts and can be searched using the Australian Heritage Database. The List can include places connected to defence, communications, customs and other government activities. Values of places on the Commonwealth Heritage List might be protected under more than one provision of the Act. For example, a Commonwealth Heritage Place might also be on the National Heritage List or the World Heritage List.

There is 1 item within the Blue Mountains LGA listed on the Commonwealth Heritage List and this place is already included in Schedule 2 of Council's LEP 1991 as a heritage item.

Register of the National Estate

Register of the National Estate is an archive of natural, Indigenous and historic heritage places throughout Australia. It was originally established under the Australian Heritage Commission Act 1975. Under that Act, the Australian Heritage Commission entered more than 13,000 places in the register. In 2004, responsibility for maintaining the Register shifted to the Australian Heritage Council, under the Australian Heritage Council Act 2003 (AHC Act).

The Australian Heritage Council can no longer add places to or remove places or a part of a place from the Register of the National Estate Register. In 2006, the Environment Protection and Biodiversity Conservation Act 1999 (the EPBC Act), and the Australian Heritage Council 2003 were amended to, among other things, freeze the Register. The Commonwealth Department of Sustainability, Environment, Water, Population and Communities states that :

The Register of the National Estate was closed in 2007 and is no longer a statutory list. All references to the Register of the National Estate were removed from the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act) on 19 February 2012.

The expiration or repeal of parts of the EPBC Act and the Australian Heritage Council Act 2003 relating to the Register of the National Estate does not diminish protection of Commonwealth heritage places.

These parts have been superseded by stronger ongoing heritage protection provisions under national environment law."

The Register of the National Estate (RNE) is now an archive of information about more than 13,000 places throughout Australia. - <u>http://www.environment.gov.au/heritage/places/rne/index.html</u> accessed 02.05.2012

There are 66 items listed on the Register of the National Estate within the Blue Mountains LGA and 65 items are already included in Schedule 2 of LEP 1991 and Schedule 6 of the 2005 LEP as heritage items. It is proposed to include 1 additional place from the RNE listings as part of the 2011 Heritage Review of the 1991 LEP. The proposed additional item is:

Asgard Mine and Coke Ovens, Victoria Falls Road, Mount Victoria

NSW STATE GOVERNMENT

The following summary outlines the NSW State bodies:

State Heritage Register

The State Heritage Register is a list of places and objects of particular importance to the people of NSW. The heritage places of NSW not only reveal the story of Australia's past; they safeguard and enrich our present and future. Retaining our limited heritage resources is green, sustainable, an investment and community building. Owners, businesses, residents and visitors all benefit as a result.

The register lists a diverse range of over 1,500 items, in both private and public ownership. To be listed, an item must be significant for the whole of NSW. The register was created in 1999 and the registers' provides legal protection for heritage items from the Heritage Act (amended 1998).

Listing on the State Heritage Register means that the heritage item:

- is of particular importance to the people of NSW and enriches our understanding of our history and identity;
- is legally protected as a heritage item under the NSW Heritage Act;
- requires approval from the Heritage Council of NSW for major changes; and
- is eligible for financial incentives from the NSW and Commonwealth governments.

There are 25 items currently listed on the State Heritage Register within the Blue Mountains LGA and 24 items are already included in Schedule 2 of LEP 1991 or Schedule 6 of the LEP 2005 as heritage items. It is proposed to include 1 additional place from the SHR listings as part of this 2011 Heritage Review of the 1991 LEP. The proposed additional item is a major group of items:

Blue Mountains Walking Tracks (various localities).

Government Agencies s170 Registers

Government agencies have responsibilities under Section 170 of the Heritage Act 1977 (NSW). Section 170 requires agencies to identify, conserve and manage heritage assets owned, occupied or managed by that agency. Section 170 requires government agencies to keep a register of heritage items, which is called a Heritage and Conservation Register or more commonly, a S.170 Register. A S.170 Register is a record of the heritage assets owned or managed by a NSW government agency.

A S.170 Register consists of a list of heritage assets and an assessment of the significance of each asset. It may also include a thematic history of the agency. The register identifies buildings, but may also include natural, movable, archaeological, landscapes and Aboriginal

heritage. The progress of agencies in preparing registers and managing their heritage assets is monitored by the Heritage Council.

Access to all section 170 Heritage and Conservation Registers is not readily available however the State Heritage Inventory Database managed by the Heritage Branch includes those Registers formally lodged to Heritage Council. The following list illustrates the range of Government agencies who are obliged to maintain a Register and the asterisk against the agencies notes an agency with its Register available for accessing through the Database with listed heritage places within the Blue Mountains LGA:

There are 45 items listed on the S.170 Registers of the Government Agencies (according to the Heritage Office Database) within the Blue Mountains LGA and 33 items are included in Schedule 2 of LEP 1991 and Schedule 6 of the 2005 LEP as heritage items. It is proposed to include 8 items listed on S.170 Registers as part of this Heritage Review and to defer 4 places for further research and investigation (refer to attached tabulation). The proposed additional items are:

- 6 items of Moveable Heritage Items at NSW Rail Transport Museum, Valley Heights

NON-GOVERNMENT BODIES AND COMMUNITY GROUPS

The following summary outlines some of the key non-Government bodies and Community groups:

Australia ICOMOS

ICOMOS, the International Council on Monuments and Sites, is the international nongovernmental organisation, established in 1965 that works to promote the application of theory, methodology and scientific techniques applied to the conservation, protection and enhancement of the world's cultural heritage. It is an official advisory body to UNESCO, and to the World Heritage Committee on the implementation of the World Heritage Convention and in the assessment of sites proposed for the World Heritage List.

Australia ICOMOS is a non-government, not-for-profit organisation of cultural heritage professionals formed as a national chapter of ICOMOS International in 1976. Australia ICOMOS' mission is to lead cultural heritage conservation in Australia by raising standards, encouraging debate and generating innovative ideas. Its members work in a diverse range of fields, engaging with local communities and recognising the economic contribution which heritage conservation makes to local and regional development.

National Trust of Australia (NSW)

The National Trust of Australia (NSW) is a non-government, community organisation with its membership open to everyone. It was established in 1945 and incorporated by an Act of the NSW Parliament in 1960. As the largest community organisation in Australia dedicated to the conservation of Australia's heritage, The National Trust of Australia (NSW) has been working for many years on the task of identifying and documenting significant places.

The task of inspecting, researching and assessing places for classification in the Trust Register is carried out in a voluntary capacity by the Trust's Landscape Conservation, Urban Conservation, Historic Buildings, Industrial Archaeology, Parks and Gardens Conservation and Cemeteries Committees, with the assistance of professional staff.

The inclusion of a place in the Register does not have any legal effect, but it is widely recognised as an authoritative statement on the significance of the place. The purpose of the Register is to alert responsible authorities, property owners and the public so that those concerned may adopt measures to preserve the special qualities which prompted the listing.

There are 90 items listed on the National Trust Register within the Blue Mountains LGA and 83 items are included in Schedule 2 of Council's LEP 1991 and Schedule 6 of the 2005 LEP as heritage items. It is proposed to include a further 3 items within this group as part of this Heritage Review and to defer 4 places for further research and investigation (refer to attached tabulation). The proposed additional items are:

- Victoria Pass (shared LEP listing with Lithgow LGA)
- Asgard Mine and Coke Ovens, Victoria Falls Road
- Lone Grave of James Ferguson, 7m from Blaxland Rd on railway embankment, 200m west of Wentworth Falls Railway Station and 9m from railway track.

The Australian Institute of Architects

The NSW Chapter of the Australian Institute of Architects has maintained a register of notable 20th century architecture since October 1949. This list should not be considered exhaustive and the RAIA considers that much work remains to be done. A special subcommittee of the NSW Chapter Heritage Committee regularly undertakes surveys and reviews nominations, as well as adding additional buildings to the register.

There are 101 items listed on the RAIA 20th Century Register of Significant Buildings within the Blue Mountains LGA and 74 items are included in Schedule 2 of Council's LEP 1991 and Schedule 6 of the 2005 LEP as heritage items. It is proposed to include a further 1 items within this group as part of this Heritage Review and to defer 26 places for further research

and investigation (refer to attached tabulation). A number of the places lie within the Leura Conservation Area listed in the BMCC LEP 2005 while for other places the addresses and property descriptions require clarification. The proposed additional items are:

Simpson Lee House, 11 Wynnes Lookout Road, Mount Wilson

Engineers Australia

The Institution of Engineers Australia, often shortened to IEAust and trading as Engineers Australia, is a professional body and not-for-profit organisation dedicated to being the national forum for the advancement of the engineering field within Australia. It has over 85,000 members from all engineering disciplines. The organisation began in the late 19th century during the Industrial Revolution, recognising the need for a single body to represent engineers, rather than the numerous smaller organisations that existed then.

It is the Engineering Heritage Australia (EHA) is Engineers Australia's peak heritage body. Its Board is comprised of representatives from each of the Division heritage groups. The Board develops policy and represents Engineers Australia nationally on engineering and industrial heritage matters. The Board also manages a number of Australia-wide programs and provides guidance and a degree of co-ordination to the engineering heritage groups located in each Division.

Engineering Heritage Australia has carriage of Engineers Australia's concerns for engineering, industrial and technological heritage and provides leadership in its protection, conservation and recording. Division engineering heritage groups are intimately involved at the State and local level in promoting the conservation of engineering heritage and in representing Engineers Australia on heritage matters. Their heritage activities include:

- identify items of engineering heritage, bringing them to public notice and promoting their recording on State and National registers,
- they are involved in educating the profession and community in the importance of engineering heritage and in recording its history e.g., awarding historic engineering plaques,
- providing input into the heritage policies and procedures of State Governments and its authorities,
- act as an interface with the community and heritage organisations to ensure the role of the engineering profession is adequately represented.

The Institution of Engineers Australia does not maintain an official register of heritage items. However, the Heritage Committee has an informal list, generally without written significance assessments, of buildings or structures considered to have heritage value.

There are 3 items listed on the EA Heritage Register within the Blue Mountains LGA and 2 items are included in Schedule 2 of Council's LEP 1991 and Schedule 6 of the 2005 LEP as heritage items. It is proposed to include a further 1 items within this group as part of this Heritage Review. The proposed additional item is:

Victoria Pass (shared LEP listing with Lithgow LGA)

The Art Deco & Modernism Society, The Art Deco Society of NSW and The Twentieth Century Heritage Society of NSW

The Art Deco & Modernism Society Inc. (ADMS) is an incorporated not-for-profit cultural organisation, operating in Victoria and throughout Australia. It is dedicated to the preservation and celebration of aspects of the Art Deco era such as architecture, landscaping, furniture, industrial design, fashion, graphics, art, jewellery, entertainment and transport. A major objective is to raise the awareness in the community of the importance of Twentieth Century buildings.

The 20th Century Heritage Society of NSW was founded in 1995, with the aim of protecting and promoting 20th Century architectural and design heritage in the state. It has attracted an impressive group of heritage practitioners, historians and specialists - united in their commitment to the conservation of our state's dwindling stock of heritage items.

These community groups do not maintain formal lists of significant buildings.

The Geological Society of Australia

The Geological Society of Australia was established as a non-profit organisation in 1952 to promote, advance and support Earth sciences in Australia. The Society's members represent all Earth science professions, including geologists, geophysicists, geochemists, palaeontologists, geotechnical and engineering geologists, environmental geologists, and associated professions.

The Subcommittees concerned with geological heritage in each Division have as their principal objectives promotion of the understanding and conservation of the geological heritage in their state or territory by:

- identification of sites and features;
- documentation of such sites and features, in a suitable form;
- evaluation of sites and features in terms of their significance, normally assigning a level of significance from local, through regional, to national and international;
- assisting in the management of sites, by monitoring and promoting their protection for geological reference and research, and for education.

The Subcommittees in each Division maintain for their state or territory a separate published and unpublished inventory of sites and features where their significance levels are assessed, whether local, regional, state, national or international. This also involves the recognition of new sites and features, and the reassessment of sites and features in the inventory from time to time. Reassessment is required by the changing nature of geology as a science as new concepts develop, by the changing needs of the geological community, and because sites and features may undergo changes in their values due to natural and human activities.

The Society was contacted during the course of the heritage review and a copy of their upto-date heritage list requested but no response was received from the organisation.

The Gap Analysis Tabulation

The following tabulation summarises the findings of the gap analysis. The basis of the tabulation is a comparative review from available information of the range of heritage listings for places within the Blue Mountains LGA by the various government and community groups with an interest in history and heritage. The information may not be complete because it relies on, in the case of State Government authorities, making their s170 listings available on

the NSW Heritage Branch database, or, in the case of community groups such as the Geological Society of Australia, having inadequate resources to complete their survey of significant sites.

Some of the heritage listings are statutory heritage listings while others, such as those by the National Trust of Australia (NSW), are simply a recognition of the significance of a place by an authoritative body. Contact was established with some of the groups but the sourcing of the data was largely from information available from an agency or group's web site. Only a few of the groups have detailed inventory sheets for individual places and therefore a complete understanding of the significance of places may sometimes be difficult to gauge without a site inspection. Site inspections have not occurred at this stage and therefore some places have been deferred for future clarification if that place has not been noted by other agencies or groups or is not known by the Heritage Advisor or Council staff.

The tabulation is structured with the various heritage agencies, bodies and groups on the top of each sheet and the property address on the left hand margin. The statutory listings are those grouped in Local, State and National / International and the non-statutory listings are those grouped in 'Other Bodies'. The places are grouped by locality commencing in the east and working westwards through the Blue Mountains, and the current LEP listing number is included for reference. The 2011 Heritage Review recommendations are also briefly included in the final column.

As can be seen from the tabulation there is not always a consistency in some of the listings because they often reflect the particular interests or focus of a particular group. However it is apparent that places of obviously high significance are often noted by more than one group. It is these places of obvious significance that the tabulated gap analysis wanted to capture and to ensure that they were either already included or should be added to the LEP schedule. The tabulation illustrated that the majority of significant places were included in the LEP 1991 or LEP 2005 schedules and only a few additional places recommended as noted in earlier paragraphs in this section of the Heritage Report.
