Aboriginal archaeological site investigation, Lot 200 DP825059, Lots 661 and 662 DP565756, Lots 64 and 65 DP754287, Lots 316 and 317 DP754308 (Daisy Hill Estate) Eulomogo Road, Dubbo NSW

## 1. Background

A rural-residential subdivision is proposed for Lot 200 DP825059, Lots 661 and 662 DP565756, Lots 64 and 65 DP754287, Lots 316 and 317 DP754308 Eulomogo Road, Dubbo NSW. Lot sizes will range from 0.6 to 6 hectares. The development will involve the creation of building envelopes, access roads and driveways. A single dwelling is proposed for each lot. The site comprises cleared agricultural land historically used for grazing and cropping.

An archaeological assessment is required as part of the development application.

## 2. Scope

- Search of the Department of Environment, Climate Change and Water Aboriginal Heritage Information Management System (AHIMS) for Aboriginal archaeological sites within Lot 64 DP754287 Eulomogo Road, Dubbo.
- Review of *Aboriginal archaeological site, Lot 64 Eulomogo Road, Dubbo NSW* prepared by Envirowest Consulting Pty Ltd, dated 4 November 2010

## 3. Method

The AHIMS database was searched for Aboriginal sites in or near the investigation area.

A review was undertaken of an aboriginal archaeological site assessment undertaken by Envirowest Consulting Pty Ltd in 2010 for Lot 64 DP254287.

## 4. Results

### 4.1 AHIMS search

The AHIMS search was undertaken on Lot 200 DP825059, Lots 661 and 662 DP565756, Lots 64 and 65 DP754287, Lots 316 and 317 DP754308 with a buffer of 50 metres.

The search of the AHIMS database found two records of Aboriginal sites recorded on Lot 64 DP754287.

No other sites were recorded or declared in or near the investigation area.

A copy of the reports are included as Attachment 1.

# 4.2 Aboriginal archaeological site, Lot 64 Eulomogo Road, Dubbo NSW - Envirowest Consulting Pty Ltd, dated 4 November 2010

The assessment identified two records of aboriginal sites listed on AHIMS located on Lot 64 DP754287. The sites were identified as an artefact and a modified tree (carved or scarred). The artefact was identified adjacent to the existing dwelling and the modified tree within the stand of remnant vegetation located in the central section of the investigation area.

The sites were identified during a survey undertaken by Lloyd Nolan of Guarra Aboriginal Site Surveys in 1998.

A consent and permit to salvage the artefact was granted in June 1999 with the artefact placed in the care and control of the Dubbo Local Aboriginal Land Council.

The assessment concluded that the development would have no impact on the artefact as it had been removed from the site. The scarred tree was not located near proposed lot boundaries and the development would have no impact on the scarred tree.

## 6. Impact of the development

The scarred tree site is within the southern section of the stand of remnant trees located in the central section of Lot 64. The development layout will protect the scarred tree remains on the site. No trees near the scar tree will be removed as part of the development. The site is not expected to be impacted by the proposed development. The scarred tree is not under direct threat from the development.

No other heritage sites are recorded or declared in or near the investigation area.

## 7. Conclusion

One sacred tree was identified in the AHIMS search as occurring on Lot 64. No impact on the scarred tree from the development is expected.

No aboriginal sites or places were identified on Lot 200 DP825059, Lots 661 and 662 DP565756, Lot 64 65 DP754287, Lots 316 and 317 DP754308

## 8. Recommendations

The scarred tree on the site should be protected in accordance with the recommendations made in the Guarra Aboriginal Site Surveys report.
