Planning Proposal – Artisan Food and Drink Industry

At the Council meeting held on Monday 13 July 2020, Council resolved to forward a Planning Proposal (enclosed) to the NSW Department of Planning, Industry & Environment and request a Gateway Determination, including the delegation of plan making powers to facilitate progression to public exhibition.

This Planning Proposal seeks to include **artisan food and drink industry** as a permissible land use with consent within the B1 - B4 *Business Zones* and RU5 *Village Zone* of the *Albury Local Environmental Plan 2010* (ALEP 2010).

By default, the use was enabled in zones where light industry is permissible so enabling this use in the B1 - B4 *Business Zones* and RU5 *Village Zone* will further encourage a range of boutique and niche providers to seek a more central or village location. This will in turn see a tourism benefit that many artisan establishments seek to capitalise on.

Accordingly, AlburyCity requests a Gateway Determination on the Planning Proposal from the Minister for Planning in accordance with Section 3.34 of the Environmental Planning & Assessment Act 1979 (EP&A Act). It is also requested that AlburyCity receive written authorisation to exercise delegation and the functions of the Minister for Planning under Section 3.36 of the EP&A Act.

AlburyCity considers the planning proposal to be not a 'low impact proposal', and accordingly, for the purposes of public exhibition would be seeking a public exhibition period for a minimum of 28 days (applicable to all other planning proposals).
