## Re: Planning Proposal to amend the land use mix controls at 301-303 Botany Road, Waterloo

I am writing in response to your Council's letter dated 17 September 2010 requesting a Gateway Determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to amend the South Sydney Local Environmental Plan 1998 to amend the Green Square Town Centre land use mix controls as they apply to 301-303 Botany Road, Waterloo (Lot X DP 413956) for the purpose of increasing residential floor space, removing requirements for commercial floor space, and introducing requirements for retail floor space.

As delegate of the Minister for Planning, I have now determined that the planning proposal should proceed subject to the conditions in the attached Gateway Determination.

The Director General's delegate has also agreed that the planning proposal's inconsistencies with S117 Direction 1.1 Business and Industrial Zones are of minor significance. No further approval is required in relation to this Direction.

The Gateway Determination requires that the planning proposal be made publicly available for a period of 14 days. Under section 57(2) of the Act, I am satisfied that the planning proposal, when amended as required by the Gateway Determination, is in a form that can be made available for community consultation.

The amending Local Environmental Plan (LEP) is to be finalised within 9 months of the week following the date of the Gateway Determination. Council should aim to commence the exhibition of the Planning Proposal within four (4) weeks from the week following this determination. Council's request for the Department to draft and finalise the LEP should be made six (6) weeks prior to the projected publication date.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under s54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

## **Gateway Determination**

**Planning Proposal (Department Ref: PP\_2010\_SYDNE\_003\_00)**: to amend the Green Square Town Centre land use mix controls as they apply to 301-303 Botany Road, Waterloo (Lot X DP 413956) for the purpose of increasing residential floor space, removing requirements for commercial floor space, and introducing requirements for retail floor space.

I, the Deputy Director General, Plan Making & Urban Renewal as delegate of the Minister for Planning, have determined under section 56(2) of the EP&A Act that an amendment to the South Sydney Local Environmental Plan 1998 to amend the Green Square Town Centre land use mix controls as they apply to 301-303 Botany Road, Waterloo (Lot X DP 413956) for the purpose of increasing residential floor space, removing requirements for commercial floor space, and introducing requirements for retail floor space should proceed subject to the following conditions:

- 1. The Planning Proposal shall, to the best extent possible, be exhibited concurrently with any exhibition for a proposed Stage 1 DA in accordance with section 72K of the Act.
- 2. Prior to exhibition, the Planning Proposal shall be amended to include consideration of Section 117 Direction 7.1 (Implementation of Metropolitan Strategy).
- 3. Prior to exhibition, the Planning Proposal shall be amended to indicate that the deferred matter status currently applying to Site No. 6 under South Sydney LEP 1998 will be removed. The amendments to the Planning Proposal should include changes to the objectives, explanation of provisions and the inclusion of a zoning map.
- 4. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
  - (a) the planning proposal is classified as low impact as described in *A Guide to Preparing LEPs (Department of Planning 2009)* and must be made publicly available for **14 days**; and
  - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 4.5 of *A Guide to Preparing LEPs (Department of Planning 2009)*.
- 5. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act:
  - Department of Housing
  - Landcom
  - NSW Transport and Infrastructure
  - Rail Corporation of NSW
  - Roads and Traffic Authority
  - State Rail
  - State Transit Authority of NSW

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material. Each public authority is to be given at least 21 days to comment on the proposal, or to indicate that they will require additional time to comment on the proposal. Public authorities may request additional information or additional matters to be addressed in the planning proposal.



- 6. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 7. The timeframe for completing the LEP is to be 9 months from the week following the date of the Gateway determination.
